6. Cancelled Insurance

- 6.1 The Supplier shall notify the Relevant Authority in writing at least five (5) Working Days prior to the cancellation, suspension, termination or nonrenewal of any of the Insurances.
- 6.2 The Supplier shall ensure that nothing is done which would entitle the relevant insurer to cancel, rescind or suspend any insurance or cover, or to treat any insurance, cover or claim as voided in whole or part. - 2.1.5 any claim made by or in respect of any person employed or formerly employed by the Former Supplier other than a Transferring Former Supplier Employee for whom it is alleged the Supplier and/or any Subcontractor as appropriate may be liable by virtue of the relevant Contract and/or the Employment Regulations and/or the Acquired Rights Directive; and

4. Information the Supplier must give

- 1.3 If an offer referred to in Paragraph 1.2.2 is accepted (or if the situation has otherwise been resolved by the Buyer and/or the Former Supplier),, the Supplier shall, or shall procure that the Subcontractor shall, immediately release the person from his/her employment or alleged employment.
- 1.4 If by the end of the 15 Working Day period referred to in Paragraph 1.2.2:
 - 1.4.1 no such offer of employment has been made:
 - 1.4.2 such offer has been made but not accepted; or
 - 1.4.3 the situation has not otherwise been resolved:

In this Part D and Part E, the following words have the following meanings and they shall supplement Joint Schedule 1 (Definitions), and shall be deemed to include the definitions set out in the Annexes to this Part D:

2. Supplier obligations to participate in the pension schemes

- 2.1 In respect of all or any Fair Deal Employees each of Annex D1: CSPS, Annex D2: NHSPS and/or Annex D3: LGPS shall apply, as appropriate.

- 4.1 The Supplier shall indemnify and keep indemnified CCS, [NHS Pensions], the Buyer and/or any Replacement Supplier and/or any Replacement Subcontractor on demand from and against all and any Losses whatsoever suffered or incurred by it or them which:
 - 4.1.1 arise out of or in connection with any liability towards all and any Fair Deal Employees arising in respect of service on or after the Relevant Transfer Date which arise from any breach by the Supplier of this Part D, and/or the CSPS Admission Agreement and/or the Direction Letter/Determination and/or the LGPS Admission Agreement;
 - 4.1.2 relate to the payment of benefits under and/or participation in a pension scheme (as defined in section 150(1) Finance Act 2004) provided by the Supplier or a Subcontractor on and after the Relevant Transfer Date until the date of termination or expiry of the relevant Contract, including the Statutory Schemes or any Broadly Comparable pension scheme provided in accordance with paragraphs 10 or 11 of this Part D;
 - 4.1.3 relate to claims by Fair Deal Employees of the Supplier and/or of any Subcontractor or by any trade unions, elected employee representatives or staff associations in respect of all or any such Fair Deal Employees which Losses:

Subcontractor:

(a) relate to any rights to benefits under a pension scheme (as defined in section 150(1) Finance Act 2004) in respect of periods of employment on and after the Relevant Transfer Date until the date of termination or expiry of the relevant Contract; or

- (b) arise out of the failure of the Supplier and/or any relevant Subcontractor to comply with the provisions of this Part D before the date of termination or expiry of the relevant Contract; and/or
- 4.1.4 arise out of or in connection with the Supplier (or its Subcontractor) allowing anyone who is not an NHSPS Fair Deal Employee to join or claim membership of the NHSPS at any time during the Term.
- 4.2 The indemnities in this Part D and its Annexes:
 - 4.2.1 shall survive termination of the relevant Contract; and
 - 4.2.2 shall not be affected by the caps on liability contained in Clause 11 (How much you can be held responsible for).

5. What happens if there is a dispute

- 5.1 The Dispute Resolution Procedure will not apply to any dispute (i) between the CCS and/or the Buyer and/or the Supplier or (ii) between their respective actuaries and/or the Fund Actuary about any of the actuarial matters referred to in this Part D and its Annexes shall in the absence of agreement between the CCS and/or the Buyer and/or the Supplier be referred to an independent Actuary:
 - 5.1.1 who will act as an expert and not as an arbitrator;
 - 5.1.2 whose decision will be final and binding on the CCS and/or the Buyer and/or the Supplier; and
 - 5.1.3 whose expenses shall be borne equally by the CCS and/or the Buyer and/or the Supplier unless the independent Actuary shall otherwise direct.

The independent Actuary shall be agreed by the Parties or, failing such agreement the independent Actuary shall be appointed by the President for the time being of the Institute and Faculty of Actuaries on the application by the Parties.

6. Other people's rights

- 6.1 The Parties agree Clause 19 (Other people's rights in this contract) does not apply and that the CRTPA applies to this Part D to the extent necessary to ensure that any Fair Deal Employee will have the right to enforce any obligation owed to him or her or it by the Supplier under this Part D, in his or her or its own right under section 1(1) of the CRTPA.
- 6.2 Further, the Supplier must ensure that the CRTPA will apply to any Sub-Contract to the extent necessary to ensure that any Fair Deal Employee will have the right to enforce any obligation owed to them by the Subcontractor in his or her or its own right under section 1(1) of the CRTPA.

7. What happens if there is a breach of this Part D

- 7.1 The Supplier agrees to notify the Buyer should it breach any obligations it has under this Part D and agrees that the Buyer shall be entitled to terminate its Contract for material Default in the event that the Supplier:
 - 7.1.1 commits an irremediable breach of any provision or obligation it has under this Part D; or
 - 7.1.2 commits a breach of any provision or obligation it has under this Part D which, where capable of remedy, it fails to remedy within a reasonable time and in any event within 28 days of the date of a notice from the Buyer giving particulars of the breach and requiring the Supplier to remedy it.

8. Transferring Fair Deal Employees

 - 8.1.1 notify the Buyer as far as reasonably practicable in advance of the transfer to allow the Buyer to make the necessary arrangements for participation with the relevant Statutory Scheme(s);
 - 8.1.2 consult with about, and inform those Fair Deal Eligible Employees of the pension provisions relating to that transfer; and
 - 8.1.3 procure that the employer to which the Fair Deal Eligible Employees are transferred (the "New Employer") complies with the provisions of this Part D and its Annexes provided that references to the "Supplier" will become references to the New Employer, references to "Relevant Transfer Date" will become references to the date of the transfer to the New Employer and references to "Fair Deal Employees" will become references to the Fair Deal Eligible Employees so transferred to the New Employer.

9. What happens to pensions if this Contract ends

- 9.1 The provisions of Part E: Staff Transfer On Exit (Mandatory) apply in relation to pension issues on expiry or termination of the relevant Contract.

 - 10.2.5 maintained until such bulk transfer payments have been received or paid (unless otherwise instructed by the Buyer).
- 10.3 Where the Supplier has set up a Broadly Comparable pension scheme pursuant to the provisions of this Paragraph 10, the Supplier shall (and shall procure that any of its Subcontractors shall):
 - 10.3.1 supply to the Buyer details of its (or its Subcontractor's) Broadly Comparable pension scheme and provide a full copy of the valid certificate of broad comparability (which remains valid as at the Relevant Transfer Date) covering all relevant Fair Deal Employees, as soon as it is able to do so before the Relevant Transfer Date (where possible) and in any event no later than seven (7) days after receipt of the certificate;
 - 10.3.2 be fully responsible for all costs, contributions, payments and other amounts relating to the setting up, certification of, ongoing participation in and/or withdrawal and exit from the Broadly Comparable pension scheme, including for the avoidance of

 - allow and make all necessary arrangements to effect, in respect of any Fair Deal Eligible Employee that remains eligible for New Fair Deal protection, following a Service Transfer, the bulk transfer of past service from any such Broadly Comparable pension scheme into the Replacement Supplier's Broadly Comparable pension scheme (or the relevant Statutory Scheme if applicable). - 11.2 Such Broadly Comparable pension scheme must be:
 - 11.2.1 established by the date of cessation of participation in the Statutory Scheme⁴;

 - capable of receiving a bulk transfer payment from the relevant Statutory Scheme (where instructed to do so by the Buyer);

 - be fully responsible for all costs, contributions, payments and other amounts relating to the setting up, certification of, ongoing participation in and/or withdrawal and exit from the Broadly Comparable pension scheme, including for the avoidance of doubt any debts arising under section 75 or 75A of the Pensions Act 1995;
 - 11.3.3 where required to do so by the Buyer, instruct any such Broadly Comparable pension scheme's Actuary to provide all such cooperation and assistance in agreeing a bulk transfer process with the Actuary to the relevant Statutory Scheme and to provide all such co-operation and assistance with any other Actuary appointed by the Buyer (where applicable). The Supplier must ensure that day for day and/or pound for pound (as applicable) (or actuarially equivalent where there are benefit differences between the two schemes) credits in the Broadly Comparable pension scheme are provided in respect of any Fair Deal Employee who consents to such a transfer from the Statutory Scheme and the Supplier shall be fully responsible for any costs of providing those credits in excess of the bulk transfer payment received by the Broadly Comparable pension scheme⁵; and

11.4 Where the Supplier has provided a Broadly Comparable pension scheme pursuant to the provisions of this paragraph 11, the Supplier shall (and shall procure that any of its Subcontractors shall) prior to the termination of the relevant Contract allow and make all necessary arrangements to effect, in respect of any Fair Deal Eligible Employee that remains eligible for New Fair Deal protection, following a Service Transfer, the bulk transfer of past service from any such Broadly Comparable pension scheme into the Replacement Supplier's Broadly Comparable pension scheme (or relevant Statutory Scheme if applicable). The bulk transfer terms provided shall be sufficient to secure day for day and/or pound for pound credits (as applicable) (or actuarially equivalent where there are benefit differences between the two schemes) in the Replacement Supplier's Broadly Comparable pension scheme (or relevant Statutory Scheme if applicable). and shall pay such set off amount to the relevant Statutory Scheme.

12.2 The Buyer shall also have a right to set off against any payments due to the Supplier under the relevant Contract all reasonable costs and expenses incurred by the Buyer as result of Paragraphs 12.1 above.

"CSPS"	the Principal Civil Service Pension Scheme available to Civil Servants and employees of bodies under Schedule 1 of the Superannuation Act 1972 (and eligible employees of other bodies admitted to participate under a determination under section 25 of the Public Service Pensions Act 2013), as governed by rules adopted by Parliament; the Partnership Pension Account and its (i) Ill health Benefits Arrangements and (ii) Death Benefits Arrangements; the Civil Service Additional Voluntary Contribution Scheme; and "alpha" introduced under The Public Service (Civil Servants and Others) Pensions Regulations 2014.

2. Access to equivalent pension schemes after transfer

In accordance with New Fair Deal, the Supplier and/or any of its Subcontractors to which the employment of any CSPS Fair Deal Employee compulsorily transfers as a result of either the award of the relevant Contract or a Relevant Transfer, if not an employer which participates automatically in the CSPS, shall each secure a CSPS Admission Agreement to ensure that CSPS Fair Deal Employees or CSPS Eligible Employees as appropriate shall be either admitted into, or offered continued membership of, the relevant section of the CSPS that they currently contribute to, or were eligible to join immediately prior to the Relevant Transfer Date or became eligible to join on the Relevant Transfer Date. The Supplier and/or any of its Subcontractors shall procure that the CSPS Fair Deal Employees continue to accrue benefits in the CSPS in accordance

but who is now ineligible to participate in the NHSPS under the rules of the NHSPS and in respect of whom the Buyer has agreed are to be provided with a Broadly Comparable pension scheme to provide Pension Benefits that are

	(a) their employment with the Buyer, an NHS Body or other employer which participates automatically in the NHSPS; or
	(b) their employment with a Former Supplier who provides access to the NHSPS pursuant to a Direction Letter/Determination or to a Broadly Comparable pension scheme in respect of their employment with that Former Supplier (on the basis that they are entitled to protection under New Fair Deal (or previous guidance), having been formerly in employment with the Buyer, an NHS Body or other employer who participated automatically in the NHSPS in connection with the Services, prior to being employed by the Former Supplier),

- 2.1 In accordance with New Fair Deal, the Supplier and/or any of its Subcontractors to which the employment of any NHSPS Fair Deal Employee compulsorily transfers as a result of either the award of this Contract or a Relevant Transfer, if not an NHS Body or other employer which participates automatically in the NHSPS, shall each secure a Direction Letter/Determination to enable the NHSPS Fair Deal Employees to retain either continuous active membership of or eligibility for the NHSPS for so long as they remain employed in connection with the delivery of the Services under the relevant Contract.
- 2.2 Where it is not possible for the Supplier and/or any of its Subcontractors to secure a Direction Letter/Determination on or before the Relevant Transfer Date, the Supplier must secure a Direction Letter/Determination as soon as possible after the Relevant Transfer Date, and in the period between the Relevant Transfer Date and the date the Direction Letter/Determination is secure, the Supplier must ensure that:

- 2.4 The Supplier must ensure (and procure that each of its Sub-Contracts (if any) ensures) that all of its NHSPS Fair Deal Employees have a contractual right to continuous active membership of or eligibility for the NHSPS for so long as they have a right to membership or eligibility of that scheme under the terms of the Direction Letter/Determination.
- 2.5 The Supplier will (and will procure that its Subcontractors (if any) will) comply with the terms of the Direction Letter/Determination, the NHS Pension Scheme Regulations (including any terms which change as a result of changes in Law) and any relevant policy issued by the Department of Health and Social Care in respect of the NHSPS Fair Deal Employees for so long as it remains bound by the terms of any such Direction Letter/Determination.
- 2.6 Where any employee omitted from the Direction Letter/Determination supplied in accordance with Paragraph 2 of this Annex are subsequently found to be an NHSPS Fair Deal Employee, the Supplier will (and will procure that its Subcontractors (if any) will) treat that person as if they had been an NHSPS Fair Deal Employee from the Relevant Transfer Date so that their Pension Benefits and NHS Premature Retirement Rights are not adversely affected.

2.7 The Supplier will (and will procure that its Subcontractors (if any) will) Subcontractor provide any guarantee, bond or indemnity required by NHS Pensions in relation to a Direction Letter/Determination.

3. Continuation of early retirement rights after transfer

3.1 From the Relevant Transfer Date until the Service Transfer Date, the Supplier must provide (and/or must ensure that its Subcontractors (if any) provide) NHS Premature Retirement Rights in respect of the NHSPS Fair Deal Employees that are identical to the benefits they would have received had they remained employees of the Buyer, an NHS Body or other employer which participates automatically in the NHSPS.

4. NHS Broadly Comparable Employees

4.1 The Supplier shall (and procure that its Subcontractors shall), with effect from the Relevant Transfer Date, offer the NHSPS Broadly Comparable Employees membership of a pension scheme which is Broadly Comparable to NHSPS on the Relevant Transfer Date in accordance with paragraph 10 of Part D. For the avoidance of doubt, this requirement is separate from any requirement to offer a Broadly Comparable pension scheme in accordance with paragraph 5.2 below.

5. What the buyer can do if the Supplier breaches its pension obligations

- 5.1 The Supplier agrees that the Buyer is entitled to make arrangements with NHS Pensions for the Buyer to be notified if the Supplier (or its Subcontractor) breaches the terms of its Direction Letter/Determination. Notwithstanding the provisions of the foregoing, the Supplier shall notify the Buyer in the event that it (or its Subcontractor) breaches the terms of its Direction Letter/Determination.

There is not 1 LGPS but approx. 90 different Funds, each with their own separate Scheme Employer and Administering Buyer, it is important to identify the correct one(s) and amend the definition of "Fund" accordingly.

It is important to check whether CCS and or the Buyer can actually participate in the LGPS. Where a government department is taking on services which were formerly the responsibility of a Local Authority it may be necessary to obtain secretary of state approval for participation in the LGPS, this is because the services are being provided to Gov. Dept. and not to a Local Authority.

Unlike New Fair Deal the 2007 Best Value pension direction does not provide a right to bulk transfer past service. Whilst typically before the 2007 direction LA did provide such a right, it is a significant additional cost and therefore bulk transfer wording has been excluded. If required take legal advice due to the exceptionally high costs which can result from a requirement to provide bulk transfers.]

4. Role of the Operational Board

1. Background

1.1 The condition

Spinal Muscular Atrophy (SMA) is an autosomal recessive neurodegenerative disease that affects the control of muscle movement, primarily affecting ability to crawl and walk, move the arms, hands, head, neck, and to breathe and swallow. It is characterised by degeneration of alpha motor neurons in the spinal cord, leading to a progressive atrophy of skeletal muscle. SMA represents the second most common fatal autosomal recessive disorder after cystic fibrosis. An estimated 1,200 people in the UK have a form of SMA with a carrier frequency of 1 in 40-60^{1,2,3}. Most cases of SMA are caused by mutations in survival motor neuron (SMN) genes, which code for the SMN protein. The most common of such mutations (95% of cases) is the absence of SMN1 gene exon 7, located on chromosome 5q13in, which is responsible for the production of proteins that are essential to motor neurons. A second centromeric SMN gene (SMN2 or SMNc) is also present in the chromosome, can partially compensate for the loss of SMN protein caused by mutations in the SMN1 gene and is considered in the diagnostic criteria of SMA.

SMA is classified traditionally into five types according to age of onset and the severity of the condition is based on motor function test (SMA types 0, 1, 2, 3, and 4). This clinical subtype classification was established before the genetic origin of SMA was understood. Mutations in the SMN1 gene have now been associated with all subtypes of SMA with no clear phenotype – genotype correlation. It is also recognised that the phenotype of SMN1-associated SMA is a continuum with no clear demarcations between subtypes. It is worth noting that the international standards of care for SMA refer to the impact of SMA on motor function as a guide to care and management needs, rather than the traditional classification based on the age at disease onset or the highest historically achieved motor function⁴. This proposed work focuses only on 5q SMA. There are some sub-types of SMN-related SMA, but they have entirely different aetiology and presentation, and they will not be considered in this work.

1.2 Current UK National Screening Committee recommendation

At present, the UK National Screening Committee (UK NSC) recommendation is that screening for SMA should not be introduced. The Committee based this recommendation on the evidence provided by the 2018 review carried out by Costello Medical. This addressed prenatal genetic carrier screening, antenatal screening and newborn screening. In relation to newborn screening the review found insufficient information about the incidence and prevalence of SMA, limited evidence to robustly quantify the accuracy of newborn screening methods, and lack of data for the long-term effectiveness and safety of nusinersen (Spinraza®), particularly in an asymptomatic population. At the time, nusinersen was the only available treatment found to be effective in improving outcomes for patients with symptomatic SMA. Studies in asymptomatic individuals were ongoing.

1.3 Changing SMA screening landscape

Since the 2018 UK NSC review, the SMA screening landscape has changed significantly. An 'early update' request to review the case for screening for SMA was submitted to the UK NSC in 2019 through the annual call for topics. The proposal drew attention to developments showing promising results in relation to the efficacy of nusinersen in asymptomatic individuals with SMA type 1 to 2, and to recent changes in the National Institute for Health and Care Excellence (NICE) guidance on the use of nusinersen as a treatment option in 5q SMA in individuals with pre-symptomatic SMA, or SMA types 1, 2 or 3. However, the information provided in the proposal did not include new evidence in relation to other criteria that were not met in the 2018 review such as the screening test. Moreover, there were concerns on the cost-effectiveness of the treatment because of the lack of evidence on the long-term benefits and the possibility of regression. Therefore, at the time the UK NSC concluded that an early update would be unlikely to change the conclusion of the 2018 review.

Since then, additional drugs such as onasemnogene abeparvovec (Zolgensma®) and risdiplam (Evrysdi®) have been made available in the NHS, though via different frameworks (more information in the section "<u>Available treatments</u>" below). In addition, a small retrospective UK study of the accuracy of PCR-based screening using anonymised leftover dried blood spots has been undertaken and published by <u>Adams et al.</u> in 2021. This is being followed up with a <u>large cohort study</u> of the accuracy and feasibility of PCR-based screening in the UK (in the Oxford region). This study is expected to last until March 2025.

These and other developments were discussed at a UK NSC stakeholder workshop in July 2021. The aim of the workshop was to stimulate a discussion on issues relating to SMA screening, consider the recent developments relating to SMA treatment and screening tests and to help the UK NSC plan the next steps to review the case for screening for SMA as part of its triennial review cycle. The developments and workshop discussions suggested that evidence maps, or evidence summaries alone would not be appropriate products for the forthcoming review and that a more comprehensive statement on the effectiveness of screening for SMA was needed.

1.4 UK NSC scoping work on newborn screening for SMA

A scoping work for a decision analytic model and cost effectiveness evaluation of newborn screening for SMA was commissioned by the UK NSC in 2022 and was carried out between 2022-2023 by the School of Health and Related Research (ScHARR) at the University of Sheffield.

The purpose of this scoping work was to prepare for a future modelling study (the project presently being procured) by fulfilling 3 objectives:

 Objective 1: conducting a review in the form of an evidence summary of available decision analytic modelling studies and cost effectiveness evaluations which address newborn screening for SMA in the era of novel treatments

- Objective 2: developing an evidence map to gauge the volume and type of published studies and evaluations of PCR-based screening and treatment in presymptomatic SMA since the 2018 UK NSC review
- Objective 3: proposing a plan for a modelling study with clinical and cost effectiveness outcomes.

ScHARR completed objective 1 which addressed the following question:

 How have modelling studies and cost effectiveness analyses addressed newborn screening for SMA in the era of novel treatments?

The review highlighted that, across all the studies, a broad range estimates were reported. These included screening being cost saving to screening generating relatively high ICERs. The review also highlighted important uncertainties not fully addressed in any of the models. These include uncertainties around the mapping of SMA phenotypes (SMA types) to SMA genotypes (number of copies of the SMN2 gene), treatment choices/mix, treatment price, and long-term effectiveness. In addition, none of the models reported in detail on the screening phase and no study considered pre-symptomatic treatment through a family history in the non-screened arm of the model. It is unclear how addressing these uncertainties in the models would impact on the projected cost-effectiveness of newborn screening for SMA.

The ScHARR review therefore recommended that a new, comprehensive and flexible cost effectiveness modelling study for the UK screening context is needed to assess the uncertainties and unanswered questions.

Objective 2 has also been completed. It addressed two key questions:

- Question 1: What is the volume and type of evidence available on PCR-based testing for newborn screening for SMA?
- Question 2: What is the volume and type of evidence on the effectiveness of pharmacological treatment for presymptomatic SMA?

ScHARR concluded that a significant volume of evidence related to both questions was identified since the previous UK NSC review in 2018. Based on the findings, the evidence map ScHARR conducted recommended that systematic reviews of PCR-based screening for SMA, as well as presymptomatic treatment of SMA, should be undertaken. These are underway and should be completed by March 2024.

The full reports addressing objective 1 and 2 will be shared with the appointed supplier after awarding of the contract.

Objective 3 is currently ongoing; it builds on objectives 1 and 2, involves stakeholder / expert workshops and focuses on: model scope, model type and structure, required data, outcomes, analytical approach, strategy for populating the model etc. Similarly, to objective 1

and 2, the findings of objective 3 will also be shared with the appointed supplier after awarding of the contract.

1.5 Available treatments

In the UK, there are now three main treatments available for SMA as follows:

Nusinersen (Spinraza®, Biogen Idec) is an antisense oligonucleotide designed to modify the product of the SMN2 gene to produce more functional SMN protein. It is administered by multiple intrathecal injections: regimens comprise loading doses (e.g.4 doses over 2 months) followed by maintenance doses (e.g. every 4 months) depending on the age of the child and severity of the disease.

- Nusinersen was recommended by NICE in 2019 for treatment of 5q SMA, including SMA types 1, 2 or 3, or presymptomatic SMA, subject to a managed access agreement (TA588).
- Nusinersen was also recommended by the Scottish Medicines Consortium (SMC) for treatment of symptomatic type 1 5q SMA, and also for types 2 and 3 SMA (the latter from July 2019 for up to 3 years while further evidence is generated).

Risdiplam (Evrysdi®, Roche) is a small molecule drug that targets the SMN2 gene to produce more SMN protein. It is administered orally on a daily basis.

- Risdiplam was recommended by NICE in 2021 for treatment of 5q SMA in people aged 2 months and older with a clinical diagnosis of SMA types 1, 2 or 3, or presymptomatic SMA and 1 to 4 SMN2 copies, subject to a managed access agreement (TA755).
- Risdiplam is also recommended by the SMC in Scotland for treatment of 5q SMA in patients aged 2 months and older with a clinical diagnosis of SMA types 1, 2 or 3, or with 1 to 4 SMN2 copies.

Onasemnogene abeparvovec (Zolgensma®; Novartis Gene Therapies) is a gene therapy product which expresses the SMN protein. It is administered once as a single-dose intravenous infusion.

- Onasemnogene abeparvovec was recommended by NICE in 2021 for treatment of 5q SMA with a bi-allelic mutation in the SMN1 gene and a clinical diagnosis of type 1 SMA in babies aged 6 months or younger (or aged 7 to 12 months if their treatment is agreed by the national multidisciplinary team), if permanent ventilation for more than 16 hours per day or a tracheostomy is not needed, and subject to a commercial arrangement. It was also recommended for presymptomatic 5q SMA with a bi-allelic mutation in the SMN1 gene and up to 3 copies of the SMN2 gene in babies, subject to a managed access agreement (HST15).
- A partial review of NICE HST15 in 2023, focussing on presymptomatic SMA, has
 published draft guidance with similar recommendations: a draft recommendation of
 onasemnogene abeparvovec for presymptomatic 5q SMA with a bi-allelic mutation in

- the SMN1 gene and up to 3 copies of the SMN2 gene in babies aged 12 months and under, subject to a commercial arrangement.
- Onasemnogene abeparvovec is also recommended by the SMC in Scotland for treatment of 5q SMA with a bi-allelic mutation in the SMN1 gene and a clinical diagnosis of SMA type 1, or presymptomatic 5q SMA patients with a bi-allelic mutation in the SMN1 gene and up to 3 copies of the SMN2 gene (where patients are expected to develop SMA type 1).

1.6 UK NSC meeting 15 June 2023

Following presentation of the results from ScHARR on the conclusions from objectives 1 and 2 and subsequent discussion, the UK NSC supported the ScHARR recommendation for the UK NSC to commission a new comprehensive and flexible modelling study for the UK screening context that addresses the uncertainties and unanswered questions.

Members considered that the existing Novartis screening model, combined with the recent NICE decision to recommend Zolgensma® for use in presymptomatic SMA, and the outcomes of the other models summarised in the ScHARR report, provide reasonable grounds for considering that a UK newborn screening programme for SMA could be cost effective. This would need to be explored in more detail and a new model would facilitate this.

To answer all the questions in a timely fashion, UK NSC also recommended to start planning an in-service evaluation (ISE) of newborn screening for SMA together with the new modelling study. A new model could help define key issues for the ISE and the ISE could then be used to collect data to feed into the model and test its assumptions. The findings of the ISE would then inform the evidence on which subsequent UK NSC decisions on recommendations on newborn screening for SMA would be based.

2. The clinical and cost effectiveness model

The UK NSC is seeking to appoint a Supplier to develop a mathematical model to estimate the clinical and cost effectiveness of newborn screening for SMA in the UK. The key question is:

Is newborn screening for SMA clinically and cost effective compared to no screening?

This question is related to UK NSC population screening criterion 18:

The opportunity cost of the screening programme (including testing, diagnosis and treatment, administration, training and quality assurance) should be economically balanced in relation to expenditure on medical care as a whole (value for money). Assessment against this criterion should have regard to evidence from cost benefit and/or cost effectiveness analyses and have regard to the effective use of available resource.

2.1 Potential scope

This model will project and compare the health benefits, harms, resource use and costs associated with newborn screening for SMA. The scope of the decision problem is briefly outlined below. Suppliers should use the information below to propose their approach to model development. The final scope will be discussed between the UK NSC evidence team and the modelling team after award of contract and will be based on the conclusions of the ongoing ScHARR work (objective 3 – see section 1.4 above).

2.3 Model structure and information for analytical approach

As a reminder to the Supplier, the ongoing UK NSC scoping work will provide a key starting point for the development of the model by delivering a document with detailed model specification and the best sources of data for populating the model as well as the work required to address any evidence gaps (e.g. systematic review, validation / generation of utilities).

These core materials will be shared with the appointed supplier after awarding of the contract.

Some points for consideration are highlighted below:

Model structure

This is expected to consist of a combination of decision tree and Markov modelling to reflect SMA health states over time. The final model structure should be justified with reference to the natural history and clinical pathway.

Clinical effectiveness sources

If possible, systematic review and meta-analysis should be used to estimate the clinical effectiveness of screening and treatment. Use of published systematic reviews undertaken elsewhere should be justified. Systematic reviews specifically of PCR-based screening for SMA and presymptomatic treatment of SMA are currently underway.

Parameters, and their sources, relating to clinical effectiveness which are not included in the systematic review should be presented. These might include studies which are less directly relevant to the clinical effectiveness of screening, but which can be linked for modelling purposes.

Costs and resource use

Costs and resource use (e.g. those associated with the intervention, comparators, health states and harms) should be presented along with their sources. Logistic measures and associated costs should be presented clearly to enable an assessment of the feasibility of screening.

Clinical / expert opinion and stakeholder involvement

The final model will be developed in an iterative process in consultation with clinical experts and other stakeholders after award of contract. Therefore, the approach to developing the model should be inclusive and transparent. Discussion with stakeholders is encouraged to develop a shared set of assumptions to ensure that the model represents disease processes appropriately and adequately addresses the decision problem.

Consideration should be given on whether a steering group is necessary throughout the duration of the project. There should be a minimum of two workshops, in addition to expert elicitation exercises which might be identified in the ongoing scoping work. The total number of workshops and their function will need to be finalised in discussions with the UK NSC evidence team.

The Supplier will be required to organise and run all workshops and expert elicitation exercises.

Ongoing dialogue should continue with stakeholders throughout the project by email and online meetings, as necessary.

Inputs and assumptions defined with reference to expert opinion should be clearly identifiable from those derived from published sources. The mechanism for incorporating these into the model should be described (e.g. selection of experts, extrapolation of primary study outcomes beyond the study follow-up period).

Utility values

The sources of utility values and their application in the model should be described. Particular consideration should be given to how best to use patient experience to generate health utilities which can then be integrated in the model.

Base case

The base case should be presented to enable comparison with the scope of the decision problem.

Sensitivity analyses

Decision uncertainty should be quantified through probabilistic sensitivity analysis (PSA). Deterministic sensitivity analysis should be used to explore the model's sensitivity to variation in individual parameters or limited sets of parameters. Selection of parameters should be justified by the importance of the parameter/s in the model. Examples of potential sensitivity analyses are below (please note: these are not exhaustive and are just an indication at present):

- uptake of screening
- adherence of population to the diagnostic and treatment pathway
- proportion of SMA babies detected via family history

Scenario analyses should be used to explore uncertainty about structural assumptions.

In-service evaluation

As previously mentioned, the UK NSC has also recommended to start planning an in-service evaluation (ISE) of newborn screening for SMA together with the new modelling study.

The requirement for the Supplier at this stage is to attend meetings and provide input and expertise into the ISE planning by using the model to help define key issues for the ISE and refine the ISE requirements. The ISE would then enable to collect data to feed into the model at a later date to test its original assumptions.

Further work may be necessary to update the model at a later stage, either during or after the ISE process. Given the strong interconnectedness between this work and any other model updates, it would not be cost-effective to engage a different supplier. Consequently, the Authority intends for the same supplier to undertake that work when and if needed.

2.4 Results

The results are to be organised in text and tables. The key resource use in physical units should be presented separately and then combined with unit costs. Ideally, outcomes should also be presented in their natural units for each strategy and then as QALYs for each strategy. The model should detail the data on average and incremental cost, average and

incremental QALYs (or other outcome if appropriate), and the incremental cost-effectiveness ratios for all strategies. The factors which drive costs and benefits should be summarised. The mutually exclusive alternatives and the decision uncertainty should be reflected using cost-effectiveness planes and cost-acceptability curves or frontiers, as appropriate.

2.5 Discussion

This section should cover the interpretation and validity of the findings of the model in light of the evidence, its stability, and methodology. The findings should also be discussed in relation to previous health economic assessments in this area to enable a comparison with current findings. The key strengths and limitations of the model and their likely influence on the estimates should be discussed. Policy implications should be stated and key evidence gaps, future research implications, and further points for discussion should be highlighted.

2.6 Dissemination

A report should be provided to the UK NSC on the development and outcomes of the model using the CHEERS and Phillips checklist^{5,6}. However, please note that these are the minimally acceptable reporting standards for the methods and the results, and that more detail may be required.

The Supplier will be required to present the final model at the UK NSC meeting, including some UK NSC reference groups meetings. The draft version agreed by the UK NSC reference groups will be sent out for a 3-month public consultation and consequently finalised for a policy decision by the UK NSC.

If necessary, the Supplier will be required to update the report based on feedback from UK NSC reference groups, public consultation and UK NSC.

Finally, the review/modelling team will work with the UK NSC evidence team to publish the model in a peer-reviewed journal. The Supplier will lead and manage the submission of the manuscript to a peer review journal, including performing a full quality check and formatting the document in line with the journal's requirements, drafting a cover letter and managing the submission process as well as the receipt and implementation of any peer-review comments. The UK NSC evidence team will contribute towards addressing any peer-review comments on the manuscript, if needed. If the first journal submission is rejected, the Supplier will be responsible for managing resubmissions to alternative journals. The UK NSC evidence team will contribute towards drafting resubmissions, if needed.

3. Project management

Regular online meetings between the Supplier's project team and the UK NSC project team will be scheduled throughout the duration of the contract. The frequency of these meetings will be decided by the Authority in collaboration with the Supplier.

4. Contract term

The contract will be for a period of 9 months with the option to extend for a further period or periods of up to 12 months.

5. Timescales and deliverables

The Suppliers will be informed of the decision in accordance with the tender timetable.

5 Budget and Payment schedule

The overall contract value is capped at £200,000 (excluding VAT). The Supplier will provide a project plan outlining key deliverables and associated deadlines.

Payment for the contract value will be made in four equal instalments. Three of these instalments will be disbursed in arrears on the 3rd, 6th, and 9th months following contract signature, contingent upon the successful completion of key deliverables specified in the Supplier's project plan during that respective period. The final instalment will be remitted upon project completion.

6 Additional Scope - Variations of Contract

The Authority may require additional services to be provided during the initial contract term and/or any applicable extension periods. Such additional services will follow the variation process as set out in clause 24 of the Call off contract terms.

Additional services/variations will be of the same nature of the contract and may include but not be limited to the following:

Impact assessment on the model proposed.

Any additional scope will be to a maximum of £50,000. Therefore, total cost for this project will be a maximum of £250,000 (excluding VAT), £300,000 including VAT.

Joint Schedule 5 (Corporate Social Responsibility)

1. What we expect from our Suppliers

- 4.1.5 record all disciplinary measures taken against Supplier Staff; and
- 4.1.6 ensure that Supplier Staff are engaged under a recognised employment relationship established through national law and practice.

5. Working Hours

- 5.1 The Supplier shall:
 - 5.1.1 ensure that the working hours of Supplier Staff comply with national laws, and any collective agreements;
 - 5.1.2 ensure that the working hours of Supplier Staff, excluding overtime, shall be defined by contract, and shall not exceed 48 hours per week unless the individual has agreed in writing:
 - 5.1.3 ensure that use of overtime is used responsibly, taking into account:
 - (a) the extent:
 - (b) frequency; and
 - (c) hours worked;

by individuals and by the Supplier Staff as a whole;

- 5.2 The total hours worked in any seven day period shall not exceed 60 hours, except where covered by Paragraph 5.3 below.
- 5.3 Working hours may exceed 60 hours in any seven day period only in exceptional circumstances where all of the following are met:
 - 5.3.1 this is allowed by national law;
 - 5.3.2 this is allowed by a collective agreement freely negotiated with a workers' organisation representing a significant portion of the workforce;
 - 5.3.3 appropriate safeguards are taken to protect the workers' health and safety; and
 - 5.3.4 the employer can demonstrate that exceptional circumstances apply such as unexpected production peaks, accidents or emergencies.
