	<p><i>In respect of the Bibby Stockholm, the Supplier shall provide a minimum of 504 accommodation spaces from the Bibby Stockholm Start Date (as defined below) to the Bibby Stockholm Expiry Date (as defined below), including sufficient bed spaces and communal spaces for 504 Service Users as set out at Annex A (Vessel Accommodation Services Requirements).</i></p> <p><i>The Supplier shall provide the Vessel Accommodation Services in respect of the Bibby Stockholm at Portland Port, UK.</i></p> <p><i>The start date for the Vessel Accommodation Services in respect of the Bibby Stockholm shall be the Full Service Commencement Date as set out at Part A of Annex B of this Order Form.</i></p> <p><i>The expiry date of the Vessel Accommodation Services in respect of the Bibby Stockholm shall be 18 months after the Full Service Commencement Date (the “Bibby Stockholm Expiry Date”).</i></p> <p><i>The Buyer may extend the period of the provision of the Vessel Accommodation Services in respect of the Bibby Stockholm in no less than six months increments up to a maximum of [18 months] so long as any extension does not extend beyond the term of this Call-Off. If the Buyer wishes to exercise such an extension, it shall give the Supplier no less than six Months' written notice.</i></p> <p><i>In consideration for the Vessel Accommodation Services in respect of the Bibby Stockholm, the Buyer shall pay to the Supplier the charges set out at Part A of Annex C of this Order Form.</i></p> <p>2.
