As this further competition has been run within the CCS Framework Number RM6119 for "Furniture and Associated Services", Lot 8: Hubs Furniture, the contract is not subject to the 'Standstill Period' as defined in the Public Contracts Regulations 2015 ("the legislation").

Therefore, it is our intention that the contract will be formally awarded to **Dams Furniture Limited**. You should note however, that in the event of any legal proceedings being brought against the decision of the proposed award of this contract, the Secretary of State for Transport will be obliged to suspend awarding the contract pending the outcome of those proceedings. We will notify you in writing if such a legal challenge is received.

This is without prejudice to the right of the Secretary of State for Transport to abandon the procurement, cancel the award procedure or suspend awarding the contract for any reason.
