Cleaning Public Toilet Facilities in Parishes of St Endellion, St Minver Highlands & St Minver Lowlands

1. About the Parishes

St Endellion, St Minver Highlands and St Minver Lowlands are Coastal Parishes lying mostly within the North Cornwall Area of Outstanding Natural Beauty. The area comprises of Polzeath, New Polzeath, Port Isaac, Rock, St Endellion in addition to other Hamlets. Key tourist attractions are the village of Port Isaac from 'Doc Martin' fame and the blue flag surf beach of Polzeath, and so visitor numbers can be very high, particularly in School Holidays. The provision of clean and safe public toilets may have a significant impact on the visitor experience to the area.

2. About the Facilities

There are 6 Public Toilet Facilities in total currently cleaned by Corserv.

All facilities are open all year, apart from Port Gaverne which closes after October half term until Easter holidays.

3. Scope of Services

This tender is to provide the community and visitors with a clean, safe, well equipped public toilet experience. Services are to include

- Daily clean of the toilets before midday(excluding 25 December)
- Clean/scour and disinfect all urinals, WC pans
- Clean/scour handwash basins
- Empty / clean litter bins.
- Sweep / Scrub / wash clean floor areas, including entrance to facility
- Collect and dispose of litter and debris within 5 metres of each building
- A weekly clean of doors, frames, window ledges, paintwork etc
- A top up evening clean is required 1 July 14 September after midday
- Replenishment of washing units with liquid soap
- Replenishment of Paper Streams, toilet roll dispensers
- Report any damages to Parish Clerk
- Facilitate 3rd Party Legionnaire testing and Sanitary waste collection
- Timesheet to be completed each visit

The purchase of consumables is also to be included in this tender. This includes toilet paper, soap etc.

4. Tender requirements

The successful tenderer will set pricing for each facility and the ongoing contract will be with the respective Parish Council.

Pricing is to divided into 12 equal monthly invoices.

Invoicing to each Parish Council in arrears on a monthly basis with 30 days payment terms.

It is recommended that employee wages are set as a minimum of the Living Wage, and annual increases correspond to Living Wage increases.

We advise a site visit to each of the facilities prior to submitting the tender.

Contracts are for 3 years with a 3 month termination period for both parties.
