



## **AMENDMENT TO CONTRACT**

The details contained in this document form a binding amendment to the Contract referenced below between the Contractor and the Secretary of State for Communities and Local Government (“DCLG”).

As set out in Contract Amendment no.1, the Contractor will continue to carry out tests on samples of cladding made by Aluminium Composite Material used in either new build or refurbishment housing.

Testing will continue for the weeks commencing 17 July 2017, 24 July 2017, 31 July 2017 and 7 August 2017 for a maximum cost of £100,000 (exclusive of Value Added Tax (VAT)).

### **Testing of cladding used in the wider public sector estate**

The Contractor will carry out further tests on samples of any cladding made by Aluminium Composite Material used in the wider public sector estate. The tests will be carried out in accordance with ISO 1716:2010.

The samples will be identified by Government Departments as part of their checks following the Grenfell Tower fire.



The following sub-contractors will assist in carrying out this work as required:

Exova (Warrington) Fire  
Edinburgh University.

Progress of work will be monitored by DCLG and Government Property Unit on a weekly basis.

#### Reporting

The Contractor will be required to provide daily reports to the Government Department requesting the testing, together with the following contacts, until instructed otherwise.

The exact requirements are to be agreed but daily reports need to include at least the following:

- Name of Government Department requesting the test(s), where known.
- Location.
- Number of samples tested.
- Where the sample is from – location of the properties.
- Number of samples found to be made from the particular type of cladding.
- Number of those from each “category”.
- A report of the result(s) will be sent to the submitting body in the format agreed by DCLG.

Costs and invoicing

The total cost of each test will be £- (excluding VAT).

The Contractor will inform DCLG when the overall cost of this testing is approaching £500,000 (excluding VAT).

Invoices shall be submitted by the Contractor on a weekly basis, in arrears, and include a full breakdown of all costs and materials for the respective period including full details of the relevant Government Department.

Terms and conditions : All terms and conditions shall remain unchanged for this Contract.
