Reason For Award of Contract: To develop the knowledge and understanding of UK capabilities in ballistic missile and ground based air defence for specialist users.

Justification For Non-Competitive Decision: Lockheed Martin (LHM) design, develop and maintain Ballistic Missile (BM) and Ground Based Air Defence (GBAD) capabilities for the Missile Defence Centre (MDC).
