Overview

UKHSA have requested 1 x 42U, 800mm wide networking enclosure. There will be an initial 6kVA / 6KW UPS installed which will require a 32A 230V P+N+E supply providing locally to the racks to enable the UPS to be connected and powered. The UPS will have one 32A switched outlet PDU connected to it to provide UPS protection to the critical network switches.

The rack will be fitted with NetBotz HID rack access control for security control at the rack level as well as having NetBotz environmental room-based monitoring which is in line with the proposed standards for rooms across UKHSA sites.


