# CONTRACT VARIATION AGREEMENT

# THIS VARIATION AGREEMENT is made on

02 February 2023

### **BETWEEN:**

**NHS COMMISSIONING BOARD** (also referred to as NHS England) of Quarry House, Quarry Hill, Leeds, LS2 7UE ("the **Authority**"); and

 Royal Free London NHS Foundation Trust of Royal Free Hospital, Pond St, London, NW3 2QG ("the Supplier").

Each a "Party" and together referred to as "the Parties".

# **BACKGROUND:**

- (A) NHS England has appointed the Supplier to provide the Services under the Service Level Agreement dated 24<sup>th</sup> June 2022 (the **Agreement**) for the provision of 'Analytical Support Services to the Children and Young People's Transformation Programme'.
- (B) The Authority and the Supplier have mutually agreed to and vary the Agreement as fully detailed below in (2) Variation.
- (C) The Authority will make payment to the Supplier as detailed below in (3) Costs.
- (D) This Agreement is not a legally binding contract, but is intended to represent a clear undertaking by NHS ENGLAND and the Supplier, to honour, observe and perform the obligations entered into to pay for and to provide services and associated activities to the standard and level detailed within this Agreement.
- (E) The Agreement transferred from NEL to Royal Free London NHS Foundation Trust with effect from 1 July 2022.

#### **IT IS AGREED** as follows:

#### 1. <u>Definitions and Interpretation</u>

• The Agreement, including any previous Variations, shall remain effective and unaltered except as amended by a Variation.

• Capitalised words and phrases in this Variation Agreement shall have the meanings given to them in the Agreement.

### 2. Variation

In accordance with Clause 3 (Variation) the Authority and the Supplier have mutually agreed to vary the Agreement.

Details of the variation:

Variation for ongoing analytical support for the data and digital workstream of the Children and Young People's (CYP) Transformation Programme. To ensure that timely data and appropriate metrics are available on CYP for clinicians, commissioners and policy leads.

# 3. <u>Costs</u>

The Supplier shall be paid a maximum of £77,000.00 for work delivered as part of the contract variation. VAT is not applicable.

This amount is in addition to the original contract £427,185 and 10% uplift of £42,718.50 previously agreed.

The variation is for the period: 01/07/2022 to 31/03/2023.
