PARTIES

- NATIONAL HIGHWAYS LIMITED, a company incorporated in and in accordance with the laws of England, having as its registered number 09346363 of Bridge House, 1 Walnut Tree Close, Guildford, Surrey, England, GU1 4LZ ("the *Client*") and
- 2 MCKINSEY & COMPANY, INC. UNITED KINGDOM a corporation incorporated under the laws of the State of Delaware, United States of America (registration number 938148) with registered address at 251 Little Falls Drive, Wilmington, Delaware 19808, United States of America (registered at Companies House in the UK as a foreign overseas entity with number FC012665) and operating in the United Kingdom through its branch establishment (BR002227) which is organized under the laws of England and Wales with registered address at The Post Building, 100 Museum Street, London, United Kingdom, WC1A 1PB (the "Consultant").

RECITALS

The Client consults with the Consultant before deciding whether information is exempt, but the Consultant acknowledges that the Client has the final decision. The Consultant co-operates with and assists the Client to publish this contract in accordance with the Client's obligation.
