Project Name: Funding Platform Business Self Service Improvements

Purpose: Innovate UK's Funding Platform is one of a number of IT systems that supports the organization in providing grants and loans to help businesses grow the development and commercialization of new products, processes, and services. The aim of the project is to increase the ability of Funding Platform end users to self-serve, alleviating impact on the Funding Platform development team and reducing the volume of service incidents and requests. The Funding Platform comprises of two parts: Pre-Award and Post-Award. The Pre-Award side is a Java/Spring based web application, with a thin JavaScript layer on the front-end and a MySQL database at the back end. The Post-Award side is a Salesforce based application, with a JavaScript/React web layer on the front-end. The identity provider (IDP) across the platform currently supports a number of service providers (SP) including the Pre-Award application, Post-Award application and a handful of Salesforce communities

Services required:

Upon assessing the team required to deliver the project we concluded that we would need a Senior Interaction Designer to work as part of the project delivery team, assisting us to design services that meet our client needs. The core requirement is to identify a supplier who can support us with the Interaction Design and development across our Funding Platform.

2. UKRI expects its suppliers and subcontractors to meet the standards set out in that Code. In addition, UKRI expects its suppliers and subcontractors to comply with the standards set out in this Schedule.
3. The Supplier acknowledges that the Buyer may have additional requirements in relation to corporate social responsibility. 1. The Supplier:

3. warrants and represents that it has not been convicted of any slavery or human trafficking offences anywhere around the world.
4. warrants that to the best of its knowledge it is not currently under investigation, inquiry or enforcement proceedings in relation to any allegation of slavery or human trafficking offenses anywhere around the world.
5. shall make reasonable enquires to ensure that its officers, employees and Subcontractors have not been convicted of slavery or human trafficking offenses anywhere around the world.
6. shall have and maintain throughout the term of each Contract its own policies and procedures to ensure its compliance with the Modern Slavery Act and include in its contracts with its Subcontractors anti-slavery and human trafficking provisions;
7. shall implement due diligence procedures to ensure that there is no slavery or human trafficking in any part of its supply chain performing obligations under a Contract;

4. Income Security

1. The Supplier shall:

1. ensure that that all wages and benefits paid for a standard working week meet, at a minimum, national legal standards in the country of employment;

 - 1.5.4 the employer can demonstrate that exceptional circumstances apply such as unexpected production peaks, accidents or emergencies.

- 1.6 All Supplier Staff shall be provided with at least one (1) day off in every seven (7) day period or, where allowed by national law, two (2) days off in every fourteen (14) day period.

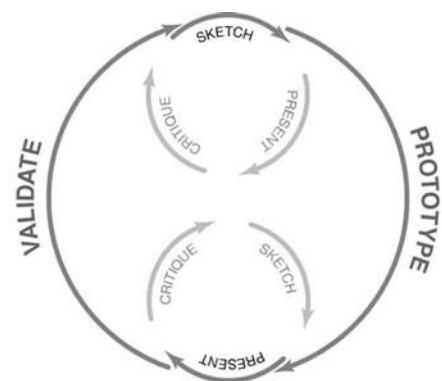


Fig.1 Continuous Feedback Approach

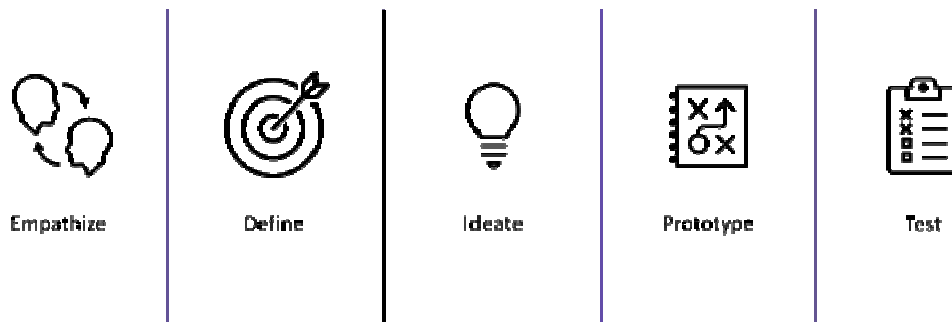
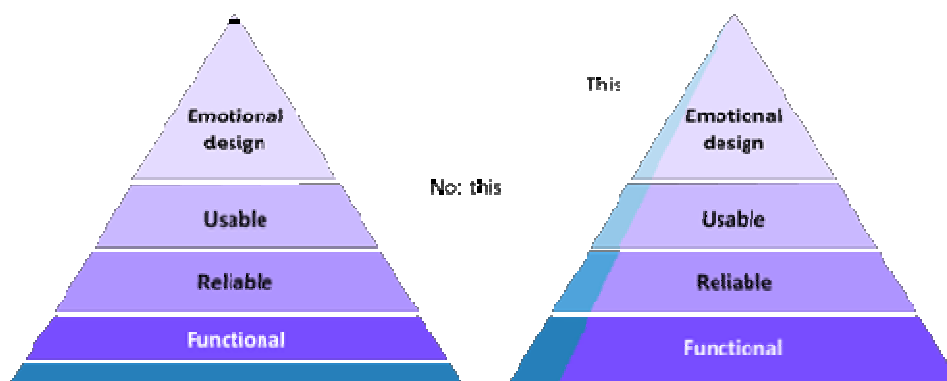


Fig.1 Design Thinking
