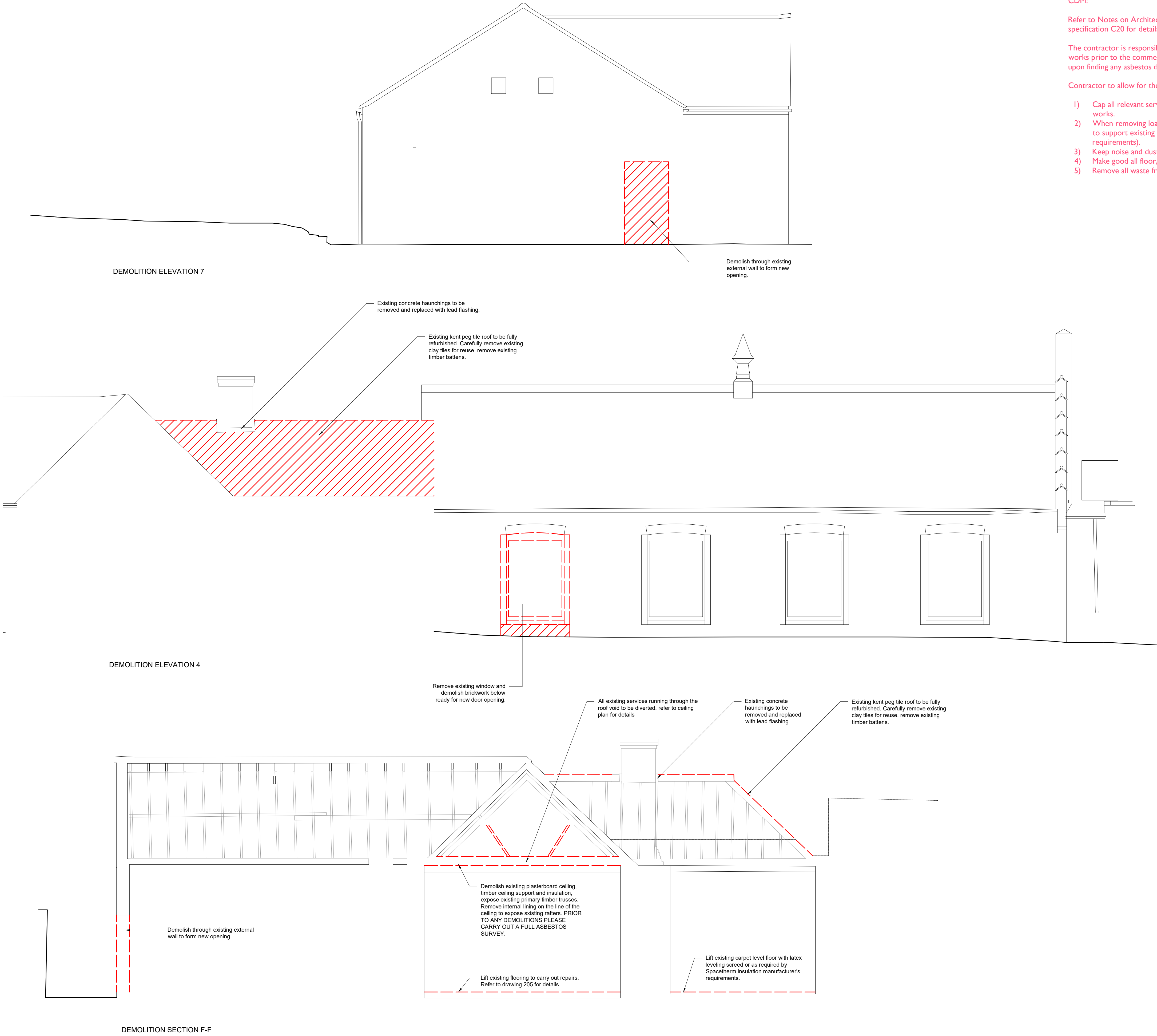
Demolition Roof Plan
