Purpose

This is a Pre-Tender Market Engagement (PTME) event only and is not a call for competition.

This PTME event seeks information for the potential procurement of a Supplier to implement and support a Remote Monitoring Partner Solution.

The purpose of this PTME is to:

- help define the requirement.
- help provide a better understanding of the feasibility of the requirement.
- understand the best approach.
- understand the capacity of the market to deliver in proposed timeframes and the possible risks involved.
- Views of the current market, specifically relating to existing and potential demand.
- Provide the market with an opportunity to ask questions, raise queries and any issues to be addressed at an early stage.

NHS Dorset ICB shall maintain commercial confidentiality of information received during the PTME.

Background

NHS Dorset ICB is developing the business requirements for a Remote Monitoring Partner solution to enable professionals to have the ability to collect and then observe information about a patient whilst the patient is not in a clinical setting (in a place they call home, including care homes).

In scope is long term conditions remote management (LTCRM), early deterioration and remote monitoring (RM).

The tender is expected to include the procurement of one Remote Monitoring Partner solution to replace the current multiple Partners used to meet the requirements for LTCRM/RM in Dorset.
