Pension calculations that are being carried out on which quality control checks are required. • This initial period will also be used to agree data access as well as to understand the quality control processes that will be carried out and how records of quality checks carried out should be logged.

- A plan will be agreed with DWP CF&I colleagues during this initial stage for the checking of up to 300 calculations. We propose some face-toface working sessions to allow for learning through shadowing examples etc.
- Once the plan has been agreed the team will commence work on Stage 2 straightaway.
- Up to 2 weeks of resource during Stage 1 will be invested by Deloitte.

Stage 2: Delivery

- The work is operating under a budgetary cap and will finish at the point at which that cap is met. We estimate this will allow c. 4 weeks of Deloitte support during Delivery. Deloitte does not have the data to attest that this will allow sufficient time to complete the review of the 300 cases.
- During this period, we will implement the agreed plan and work with CF&I colleagues to review State Pension calculation checks carried out by DWP. We will closely monitor progress against the target of 300 cases.
- In addition our resources will seek to identify ways in which quality control checks could be carried out more efficiently.
- Any decisions on levels of payment to be made with respect to individual cases following review and quality control checks will be made by DWP.
- All work on Stage 2 is assumed to be completed remotely.
