- 1.1. To seek to identify, recruit and train assessors, from across the UK, with experience across all education sectors: Schools; Further Education and Higher Education, by end-March 2024.
- 1.2. To ensure that all eligible applications (up to 800) are assessed within a sixweek assessment period over April 2024 to May 2024 and provide a mechanism for real time progress reporting.
- 1.3. To ensure that those applications deemed eligible for appeal, (around 20% of unsuccessful) are reassessed by beginning July 2024.
- 1.4. To provide DfE with written feedback for each application assessed within 10 working days of completion of the assessments.
