All tenders will be opened at the same time by the CEO or Finance Director, the Project Manager and in the presence of a Councillor.

You must submit the following documentation with your tender:

- 1) Any company accreditations, qualifications, and recognitions.
- 2) Evidence of your staff/team's competency and training records.
- 3) The details of your proposed Health & Safety documentation you will supply for this project should you be successful.
- 4) Example RAMS from a similar project.
- 5) A company organogram.
- 6) TDAC04 'Application Form for the Bridgwater Town Council Approved Contractor'.
- 7) Insurance details and certificates as indicated in section C of TDAC04 (please note that £10m liability is required).



- 8) TDAC05 'Tender Declaration Form'
- 9) TDAC06 'Form of Tender'.

- 11) TDAC08 'Supplier Technical Questions & Answers Sheet'

Any omissions will invalidate your tender.
