Section 5: Summary of Requirements / Description of Work:

1. Information technology services. Software implementation services. As a part of MOD's acknowledgement of Cyber as a Tier One risk to UK interests, a 10-year funding stream was provisioned for Defensive Cyber Capabilities (DCC) to support Defensive Cyber Operations (DCO), developed through the MOD Cyber Programme (MODCyP). This seeks to enhance MOD's cyber capabilities in predicting, detecting and defending against cyber threat vectors across the Defence enterprise and has rapidly matured over the last few years. As part of this work towards fully realising the DCC Vision, the MODCyP is looking to further expand DCC through Project DICE, complementing extant DCC capabilities already in operational use.

1.1. In alignment with the approach taken across DCC, DICE will adopt a loosely coupled, service-oriented architecture. It will allow MOD-wide system and security event logging information to be centrally collated and subsequently exploited through a range of flexible and adaptable tools. The capability being introduced through DICE will support a wide variety of DCO stakeholders alongside the emerging Cyber Security Operations Capability (CSOC) community.

1.2. The Service Integrator (SI) Industry Partner will bring in SQEP resources to work alongside the MODs Cyber Delivery Team (CDT). These resources will be expected to undertake development and implementation of the core DICE architecture within a provided private cloud service as well as support integration of a range of data feeds. The SI will also be expected to support CDT in establishing suitable agile operational support structures for maintaining and developing the capability once brought into live operational use, including the potential establishment of an operational core support team.
