

PHE\_Scientific - Provision of Flexible film isolators - (Contract ref: ECM 7943)

This Contract is made between:

The Secretary of State for Health and Social Care acting as part of the Crown through Public Health England of 133-155 Waterloo Road, London, SE1 8UG (the "Authority")

and

**PFI Systems Ltd** of 44 Potters Lane, Milton Keynes, Buckinghamshire, MK11 3HQ (the "Supplier")

The following is agreed:

- 1. The Contract is made up of the following documents:
  - (a) this Form of Contract for invitation to tender reference number itt\_4536 PHE\_Scientific Provision of Flexible film isolators;
  - (b) the Specification and Tender Response (but only in respect of the Authority's requirements, including any clarifications of the requirements agreed by the Authority as part of the tender process);
  - (c) Schedule 1: Optional Provisions, if any;
  - (d) Schedule 2: General Terms and Conditions;
  - (e) Schedule 7: Commercial Schedule.
  - (f) Schedule 3: Information Governance Provisions:
  - (g) Schedule 4: Definitions and Interpretations;
  - (h) the order in which all subsequent schedules appear, if any;
  - (i) the Specification and Tender Response (other than those parts referred to in (b) above;
  - (j) any other documentation forming part of the Contract in the date order in which such documentation was created with the more recent documentation taking precedence over older documentation to the extent only of any conflict.

(all of the above documents taken together (as amended in accordance with this Contract) being referred to as the "Contract")

2. Subject always to Clause 1.10 of Schedule 4, if there is an inconsistency between any of the documents listed above, the order of priority for construction purposes shall be that a higher listed document shall prevail over a lower listed document, i.e. document (a) shall prevail over all other documents; document (b) shall prevail over document (c).



- 3. The Contract will commence on 19<sup>th</sup> February 2021 (the "Commencement Date") and shall expire 3 year from the Commencement Date with optional 2 years extension, subject to written agreement at the end of contract period.
- 4. Prior to each call-off order, the Authority will present requirements for Flexible Film Isolators to all preferred suppliers identified in the ITT\_4536. Each supplier will be given equal opportunity to present their proposal to the Authority, including technical and commercial aspects of the solution. The Authority will prefer most economically advantageous solution presented. In the unlikely event of equal solutions being presented by all suppliers, Bell Isolation Systems Ltd. will be preferred as the primary supplier due to the overall higher score achieved in the tender.
- 5. All spare parts, consumables and any items that require continuous supply (including canopies), related to any equipment that is subject to this contract, will be sourced from the Supplier of the equipment.

- 8. The 12-months warranty period of the equipment will commence on the date of installation and commissioning acceptance by the Authority.
- 9. The value of the contract is £425000 (excluding VAT).
