

AMENDMENT OF G-CLOUD 13 CALL-OFF CONTRACT (PS/23/82)

Driver & Vehicle Licensing Agency (the “**Buyer**”) and Gartner UK Limited (the “**Supplier**”) hereby agree that the G-Cloud 13 Call-Off Contract (ref: PS/23/82) between the parties with the Start Date 1st July 2023 (the “**Call-Off Contract**”) shall be amended as set out herein.

The parties agree the following:

- 1. Effective as of 1st February 2024, the Services set out in Call-Off Contract shall be removed (the “**Removed Services**”) and replaced with the Services set out in the Order Schedule below (the “**Replacement Services**”).
- 2. The expiry date of the Call-Off Contract shall be amended to 31st January 2025.
- 3. The Buyer shall receive a credit for the already paid amount corresponding to the unused contract term of the Removed Services (period 1st February 2024 to 30th June 2024). Such credit shall be applied to the invoice issued for the Replacement Services, as set out in the Order Schedule below. For the avoidance of doubt, any credit is subject to confirmation of payment previously made to the Supplier.
- 4. The Charges for the Replacement Services will be invoiced annually in advance upon signature of this Amendment.


