Section 4 – Specification

1. Background

In the British Energy Security Strategy (BESS), published in April 2022, the Government stated it expects up to a fivefold increase in UK solar PV capacity by 2035, up to 70GW by that year. Both large-scale ground-mounted, and smaller-scale commercial and domestic rooftop installations are essential to meeting that commitment. This will support decarbonisation, help reduce Britain's reliance of imported fossil fuels, reduce electricity bills for households and businesses, and support job creation. It can also help bring valuable system flexibility, especially when collocated with electric vehicles, heat pumps, and innovative AI enabled batteries ('smart solar' systems).

The five-fold ambition for total capacity implies a substantial and sustained level of rooftop deployment over the next decade, implying a significant amount of total investment by households and firms. BEIS data does suggest the rate of rooftop scale deployment has increased in 2022¹, likely due to consumers' concerns about high and rising retail electricity bills; ensuring this trend continues, and where possible accelerates, is a key Government ambition. BEIS continues to work on the future of policy and strategy for rooftop PV, as it is an important technology to support wider decarbonisation, energy affordability and energy security objectives. Existing BEIS commissioned evidence has highlighted the significance of upfront financial costs as a barrier to rooftop deployment for some households, and concerns around financial returns as a key factor for small businesses, suggesting financing support as the main avenue for future policymaking.^{2 3}

There is currently limited up to date and detailed evidence on the numerical range of costs and benefits from rooftop PV to consumers, now and into the future, and what this implies for how this deployment can be supported through financing arrangements. Present cost of living and energy price rises mean securing detailed and current evidence on these issues is even more critical than would otherwise be the case. BEIS publishes data annually on estimated PV costs from actual installations.⁴ Whilst useful as an assessment of current market conditions, these data exist only at the £ per kW level for relatively wide ranges of kW size installations, do not breakdown by components or project future costs, and do not include details on financial benefits. 'Calculator' style products for comparing costs and benefits do exist online, but these are consumer focussed services that are not well suited to detailed policymaking.⁵

This project will develop a robust evidence base on costs and benefits of rooftop solar for

households and small businesses, and what this implies for routes to supporting low-cost financing for installations. This is in the context of the British Energy Security Strategy⁶ (BESS) commitment to facilitate ‘low-cost finance from retail lenders to drive rooftop [PV] deployment’.

2. Aims and Objectives

The project will help provide the numerical evidence base to inform decisions and formal economic appraisal on how policy intervention could support more affordable financing for rooftop PV.

Research Questions

- i. What are the costs (excluding wider power system costs) for households and small businesses in the UK of installing rooftop PV now and (through illustrative scenarios) over time into the future (ideally, out to 2050)?
 - Where possible this should include costs breakdown by module, inverter, labour, connection costs, ongoing maintenance costs etc.
 - Attention should be paid to how costs vary by size of installation (in kW), including economies of scale.
- ii. What are the costs of domestic batteries now (through illustrative scenarios) and into future (ideally, out to 2050)?
 - Where possible this should include a breakdown of different components of overall costs.
 - Where possible this should make note of the role of ‘smart’ batteries that automatically manage electricity use to respond to price signals.⁷
- iii. What are the benefits over time from foregone retail bills and SEG (or other?) payments?
 - Ideally this should consider benefits across solar only, solar and (smart) storage, solar and storage + EVs/Heat Pumps, and different tariff option scenarios.
 - Numerical analysis should be based on plausible illustrative ranges for key variables (most notably retail electricity costs and export payments) into future.
- iv. Given these costs and benefits, what are potential high level viable financing arrangements (led by retail banks or other private financial institutions with Government backing/support) to support sustainable affordable deployment by households and small businesses?
 - This does not need to be answered through detailed financial product design suggestions or policy recommendations or take consideration of detailed legal or regulatory matters (BEIS is considering these elements through internal policy work and engagement).
 - Rather, from this research we want a sense of what design choices in a finance product (e.g. levels of interest rate, loan period length, repayment structure) could accommodate full or partial upfront financing whilst ensuring affordable repayments from the perspective of the household/small business, i.e. repayments should not overly outweigh financing savings from the asset, and thus should still enable net savings.

- We also anticipate that it will be helpful to provide evidence of these types of financial product being used in comparable markets/overcoming similar constraints (see methodology section for more details on this element)

3. Suggested Methodology

Please note that we are amenable to alternative suggested approaches (including different levels of primary and secondary and quantitative and qualitative research) to answer our questions within our timeline and budget.

We suggest the first three research questions be approached through structured desk research to identify and analyse existing key datasets. This will likely need to be followed as needed by bespoke and structured expert elicitation of those with detailed industry knowledge of costs / benefits of rooftop solar systems. It may be helpful to use a typology of hard vs soft costs, particular to inform analysis on how/why costs may change over time; see Beck and Rai 2019 as one example for solar PV.⁸ Where used, expert elicitation should be highly targeted to ensure delivery within budget and timelines and focus on gathering evidence on variables for which there is the greatest uncertainty about values into the future according to the existing evidence gathered through desk research.

Existing BEIS published work on heat pump costs could serve as a useful high level reference point for the types of analysis we are interested in, although note for this project we are also interested in benefits (i.e., savings, and export revenues) from rooftop PV.⁹ Key data inputs on benefits are likely to include trajectories for future retail electricity payments, and export (Smart Export Guarantee) payments.

Existing work by the Microgeneration Certification Scheme on PV self-consumption is likely to also be useful.¹⁰ Numerical evidence and modelling should be structured and presented clearly, with a record of relevant inputs and calculations in Excel or other suitable software. To answer the research question on viable financing approaches, we would also anticipate the supplier of this research to conduct a structured Rapid Evidence Assessment (e.g. using a structured approach to finding and filtering evidence by relevance and reliability) of the considerable existing literature on rooftop PV deployment and existing international financing policy schemes for PV and related technologies, as well as the existing PV financing market in the UK, and relevant policies in other markets (such as the PACE scheme in the United States).¹¹

It may also be productive to compare at a high-level examples of financing support for PV against those for complementary technologies like domestic energy efficiency measures, heat pumps, and electric vehicles, although the main focus must be on PV. We would expect numerical results from the first three questions could be used to describe high level case studies of possible financing approaches to support rooftop deployment in the UK, now and into the future, taking note of factors such as interest rates, loan length and its relation to PV 'payback periods', and repayment structure.

Note that we do *not* expect detailed financial modelling within the scope of the research project as listed in this tender; such modelling is a possible next step of analysis for this workstream which BEIS may look to commission at a later stage.

4. Deliverables

Research report of publishable quality detailing the approach, results, and key insights of the project. Exact timelines can be subject to discussion with a successful contractor, but ideally an interim version of this should be completed and sent to BEIS by end of January 2023 or early February., with a final version completed and provided to BEIS (following drafting and iteration as needed) by the end of February 2022 or early March.

Spreadsheet(s) with all data inputs/assumptions and sources, and as needed an assessment of data quality and uncertainty. This would ideally function as an interactive tool to assess costs and benefits under different input assumptions.

PowerPoint slide deck and presentation to key officials, on same content as in the research report.

Questionnaire documentation for if applicable

Quality Assurance (QA) summary.

QA log for modelling if applicable, in line with Aqua book/BEIS modelling standards.

Evaluation of criteria

Non-Commercial Elements

Each question will be judged on a score from 0 to 100, which shall be subjected to a multiplier to reflect the percentage of the evaluation criteria allocated to that question.

Where an evaluation criterion is worth 20% then the 0-100 score achieved will be multiplied by 20%.

Example if a Bidder scores 60 from the available 100 points this will equate to 12% by using the following calculation:

$$\text{Score} = \{\text{weighting percentage}\} \times \{\text{bidder's score}\} = 20\% \times 60 = 12$$

The same logic will be applied to groups of questions which equate to a single evaluation criterion.

The 0-100 score shall be based on (unless otherwise stated within the question):

0	The Question is not answered, or the response is completely unacceptable.
10	Extremely poor response – they have completely missed the point of the question.
20	Very poor response and not wholly acceptable. Requires major revision to the response to make it acceptable. Only partially answers the requirement, with major deficiencies and little relevant detail proposed.
40	Poor response only partially satisfying the question requirements with deficiencies apparent. Some useful evidence provided but response falls well short of expectations. Low probability of being a capable supplier.
60	Response is acceptable but remains basic and could have been expanded upon. Response is sufficient but does not inspire.
80	Good response which describes their capabilities in detail which provides high levels of assurance consistent with a quality provider. The response includes a

	full description of techniques and measurements currently employed.
100	Response is exceptional and clearly demonstrates they are capable of meeting the requirement. No significant weaknesses noted. The response is compelling in its description of techniques and measurements currently employed, providing full assurance consistent with a quality provider.

All questions will be scored based on the above mechanism. As there will be multiple evaluators their individual scores and commentary will be recorded, then a consensus meeting will be convened by the evaluators to determine your score. Note this will include a chairperson or lead and all evaluators are of equal status.

Example
 Evaluator 1 scored your bid as 60
 Evaluator 2 scored your bid as 60
 Evaluator 3 scored your bid as 40

The convened meeting came to a consensus that the final recorded score to given to your submission against this question should be 60, with the justification and reasons for this score recorded.

Once the consensus process has been finalised, all justifications recorded and all non-priced scores are agreed, this will then be subject to an independent commercial moderation review.

Commercial Elements will be evaluated on the following criteria.

The lowest price for a response which meets the pass criteria shall score 100. All other bids shall be scored on a pro rata basis in relation to the lowest price. The score is then subject to a multiplier to reflect the percentage value of the Commercial criterion.

For example - Bid 1 £100,000 scores 100.
 Bid 2 £120,000 differential of £20,000 or 20% remove 20% from price scores 80
 Bid 3 £150,000 differential £50,000 remove 50% from price scores 50.
 Bid 4 £175,000 differential £75,000 remove 75% from price scores 25.
 Bid 5 £200,000 differential £100,000 remove 100% from price scores 0.
 Bid 6 £300,000 differential £200,000 remove 100% from price scores 0.

Where the scoring criterion is worth 50% then the 0-100 score achieved will be multiplied by 50.

In the example if a supplier scores 80 from the available 100 points this will equate to 40% by using the following calculation: Score/Total Points multiplied by 50 (80/100 x 50 = 40)

The lowest score possible is 0 even if the price submitted is more than 100% greater than the lowest price.

This evaluation criteria will therefore not be subject to any averaging, as this is a mathematical scoring criterion, but will still be subject to a commercial review.

Section 7 – General Information

What makes a good bid – some simple do's 😊

DO:

- 7.1 Do comply with Procurement document instructions. Failure to do so may lead to disqualification.
- 7.2 Do provide the Bid on time, and in the required format. Remember that the date / time given for a response is the last date that it can be accepted; we are legally bound to disqualify late submissions. Responses received after the date indicated in the Section 3 of the ITQ shall not be considered by the Contracting Authority, unless the Bidder can justify that the reason for the delay is solely attributable to the Contracting Authority
- 7.3 Do ensure you have read all the training materials to utilise the eSourcing portal prior to responding to this Bid. If you send your Bid by email or post it will be rejected.
- 7.4 Do use Microsoft Word, PowerPoint Excel 97-03 or compatible formats, or PDF unless agreed in writing by the Buyer. If you use another file format without our written permission, we may reject your Bid.
- 7.5 Do ensure you utilise the Jaggaer eSourcing messaging system to raise any clarifications to our ITQ. You should note that we will release the answer to the question to all Bidders and where we suspect the question contains confidential information, we may modify the content of the question to protect the anonymity of the Bidder or their proposed solution
- 7.6 Do answer the question, it is not enough simply to cross-reference to a 'policy', web page or another part of your Bid, the evaluation team have limited time to assess bids and if they can't find the answer, they can't score it.
- 7.7 Do consider who the Contracting Authority is and what they want – a generic answer does not necessarily meet every Contracting Authority's needs.
- 7.8 Do reference your documents correctly, specifically where supporting documentation is requested e.g. referencing the question/s they apply to.
- 7.9 Do provide clear, concise and ideally generic contact details; telephone numbers, e-mails.
- 7.10 Do complete all questions in the evaluation response questionnaire or we may reject your Bid.
- 7.11 Do ensure that the Response and any documents accompanying it are in the English Language, the Contracting Authority reserve the right to disqualify any full or part responses that are not in English.
- 7.12 Do check and recheck your Bid before dispatch.

DO NOT

- 7.13 Do not cut and paste from a previous document and forget to change the previous details such as the previous buyer's name.
- 7.14 Do not attach 'glossy' brochures that have not been requested, they will not be read unless we have asked for them. Only send what has been requested and only send supplementary information if we have offered the opportunity so to do.
- 7.15 Do not share the Procurement documents, they are confidential and should not be shared with anyone without the Buyers written permission.
- 7.16 Do not seek to influence the procurement process by requesting meetings or contacting UK SBS or the Contracting Authority to discuss your Bid. If your Bid requires clarification the Buyer will contact you. All information secured outside of formal Buyer communications shall have no Legal standing or worth and should not be relied upon.
- 7.17 Do not contact any UK SBS staff or the Contracting Authority staff without the Buyers written permission or we may reject your Bid.
- 7.18 Do not collude to fix or adjust the price or withdraw your Bid with another Party as we will reject your Bid.
- 7.19 Do not offer UK SBS or the Contracting Authority staff any inducement or we will reject your Bid.
- 7.20 Do not seek changes to the Bid after responses have been submitted and the deadline for Bids to be submitted has passed.
- 7.21 Do not cross reference answers to external websites or other parts of your Bid, the cross references and website links will not be considered.
- 7.22 Do not exceed word counts, the additional words will not be considered.
- 7.23 Do not make your Bid conditional on acceptance of your own Terms of Contract, as your Bid will be rejected.
- 7.24 Do not unless explicitly requested by the Contracting Authority either in the procurement documents or via a formal clarification from the Contracting Authority send your response by any way other than via the Jaggaer eSourcing portal. Responses received by any other method than requested will not be considered for the opportunity.

- 7.26 Bidders will be specifically advised where attachments are permissible to support a question response within the eSourcing portal. Where they are not permissible any attachments submitted will not be considered as part of the evaluation process.
- 7.27 Question numbering is not sequential and all questions which require submission are included in the Section 6 Evaluation Response Questionnaire.
- 7.28 Any Contract offered may not guarantee any volume of work or any exclusivity of supply.
- 7.29 We do not guarantee to award any Contract as a result of this procurement
- 7.30 All documents issued or received in relation to this procurement shall be the property of the Contracting Authority / UK SBS.
- 7.31 We can amend any part of the procurement documents at any time prior to the latest date / time Bids shall be submitted through the Jaggaer eSourcing Portal.
- 7.32 If you are a Consortium you must provide details of the Consortiums structure.
- 7.33 Bidders will be expected to comply with the Freedom of Information Act 2000, or your Bid will be rejected.
- 7.34 Bidders should note the Government's transparency agenda requires your Bid and any Contract entered into to be published on a designated, publicly searchable web site. By submitting a response to this ITQ Bidders are agreeing that their Bid and Contract may be made public
- 7.35 Your bid will be valid for 90 days or your Bid will be rejected.
- 7.36 Bidders may only amend the contract terms during the clarification period only, only if you can demonstrate there is a legal or statutory reason why you cannot accept them. If you request changes to the Contract terms without such grounds and the Contracting Authority fail to accept your legal or statutory reason is reasonably justified, we may reject your Bid.
- 7.37 We will let you know the outcome of your Bid evaluation and where requested will provide a written debrief of the relative strengths and weaknesses of your Bid.

- 7.38 If you fail mandatory pass / fail criteria we will reject your Bid.
- 7.39 Bidders are required to use IE8, IE9, Chrome or Firefox in order to access the functionality of the Jaggaer eSourcing Portal.
- 7.40 Bidders should note that if they are successful with their proposal the Contracting Authority reserves the right to ask additional compliance checks prior to the award of any Contract. In the event of a Bidder failing to meet one of the compliance checks the Contracting Authority may decline to proceed with the award of the Contract to the successful Bidder.

8.0 Freedom of information

- 8.1 In accordance with the obligations and duties placed upon public authorities by the Freedom of Information Act 2000 (the 'FoIA') and the Environmental Information Regulations 2004 (the 'EIR') (each as amended from time to time), UK SBS or the Contracting Authority may be required to disclose information submitted by the Bidder to the to the Contracting Authority.
- 8.2 In respect of any information submitted by a Bidder that it considers to be commercially sensitive the Bidder should complete the Freedom of Information declaration question defined in the Question FOI1.2.
- 8.3 Where a Bidder identifies information as commercially sensitive, the Contracting Authority will endeavour to maintain confidentiality. Bidders should note, however, that, even where information is identified as commercially sensitive, the Contracting Authority may be required to disclose such information in accordance with the FoIA or the Environmental Information Regulations. In particular, the Contracting Authority is required to form an independent judgment concerning whether the information is exempt from disclosure under the FoIA or the EIR and whether the public interest favours disclosure or not. Accordingly, the Contracting Authority cannot guarantee that any information marked 'confidential' or "commercially sensitive" will not be disclosed.
- 8.4 Where a Bidder receives a request for information under the FoIA or the EIR during the procurement, this should be immediately passed on to UK SBS or the Contracting Authority and the Bidder should not attempt to answer the request without first consulting with the Contracting Authority.

“Contracting Authority”	A public body regulated under the Public Procurement Regulations on whose behalf the procurement is being run
“Customer”	means the legal entity (or entities) for which any Contract agreed will be made accessible to.
“Due Diligence Information”	means the background and supporting documents and information provided by the Contracting Authority for the purpose of better informing the Bidders responses to this ITQ
“EIR”	mean the Environmental Information Regulations 2004 together with any guidance and / or codes of practice issued by the Information Commissioner or relevant Government department in relation to such regulations
