DFID Pakistan is seeking a Supplier to work with the Government of Punjab to manage and implement a programme of support to the Special Monitoring Unit. The support could be in the form of provision of technical advice and facilitation of knowledge and skills transfer to the Special Monitoring Unit as they strive to become an independent delivery unit. The coordination of effective capacity development in the wider Government and enabling collaboration and communication between the Special Monitoring Unit, DFID and the relevant government departments is also envisaged. Suppliers are invited to complete all requirements of this one-stage Open Procedure. The contract will be issued for 18 months, and will have a break point after 9 months.
