	Date	Question	Response
Q001		Which external organisations have supported the Discovery phases and will they be invited to bid for this work?	External support was provided during Discovery. We will confirm whether those organisations will be bidding, subject to commercial sensitivities
Q002	22/May/25	To what extent is the Government Digital Service (previously Geospatial Commission) involved?	The programme is aligned with the Geospatial Commission. We've had prior engagement and aim to strengthen that alignment going forward, particularly around standards and broader strategy
Q003	-	Could you provide more details about the common spatial framework and its current remit?	The common spatial framework is a conceptual base map of England to support operational, policy, regulation, environmental tracking. It is intended to provide a single authoritative view of land, reducing duplicaiton, inaccuracies and supporting interoperability. It must be able to have regular refresh functionality for whole map and individual updates.
Q004	-	How far into establishing the Data Standards are you? is there a proposed data schema?	Work is at an early stage. Inspire standards are currently used across Defra, We are enagaing with the Chief Data Office and the Geospatial Commission to ensure consistency, but a formal schema is not yet established.
Q005		If you have an input aerial photo, can you confirm the integration of EO data?	EO and aerial imagery may be integrated depending on user needs identified during Alpha. We are open to assessing existing tools or sourcing new data based on user requirements.
Q006	22/May/25	Have you undertaken a data maturity assessment?	Not directly through this programme. However Defra Chief Data Office has undertaken data maturity assessments across the group, and we are aligned with that work

Q007	22/May/25	Beyond the current partners, are there other partners that could benefit from this in the longer term? E.g. other gov dept; public open data?	yes, there is potential for wider use across Government and by the public, but this will be determined based on ongoing user needs and engagement with groups like Geospatial Commission.
Q008	22/May/25	In terms of the operational model for this program, where would DEFRA want this work to be executed- onsite, onshore, offshore or in a hybrid mode?	Onshore delivery is expected. Suppliers need not be based on Defra premises, but will be expected to attend monthly meetings, potentially at a central location such as Crewe.
Q009	22/May/25	We're working on DBT's National Digital Twin Programme and can see benefits in collaboration and data sharing when the time's right. Have you explored to date?	The potential has been noted. Whilst not actively linked with DBTs programme currently, alignment and collaboration opportunities may be explored as the programme evolves.
Q010	22/May/25	Is there a need for commercial satellite data for the basemap not just aerial imagery?	this depends on user requirements. The Alpha phase will determine is existing data is sufficient or if new sources , including commercial satelite data are needed
Q011	22/May/25	Can you share any thoughts on what your ideal partner would be like (capabilities, culture, ways of working etc.)	The ideal partner will demonstrate geospatial expertise in a regulated/government context, experience of government agile delivery, collaborative ways of working and ability to work with SMEs and across complex stakeholder groups
Q012			This will be the basis of a design decision that will be required during alpha/design stage. Based on user and business requirement, the options of a) current infrastructure can support b) current infrastructure with expansion and changes can support c) current infrastructure cannot support will be explored and decided.
Q013	22/May/25	Are you willing to accept larger organisations paired with SME's?	Yes. Collabortaion with SMEs is encouraged. This could be via consortia or subcontracting to ensure required specialist capability is delivered
Q014	22/May/25	What is the budget for this procurement?	Budget cannot be confirmed at this stage, more detail may be provided in due course
Q015	22/May/25	Given the tender is likely to be awarded to a larger organisation, how should SMEs find out which larger organisations are bidding to form partnerships?	SMEs are encouraged to network with larger suppliers via the DPS and early engagement events. We support visibility and will consider what we can do to facilitate this further

22/May/25	Hello, are you looking for any project/ programme management support from your delivery partner(s)?	Not at present. Project and programme management is being resourced seperately
22/May/25	Is there any leeway on the response time as it falls over the summer school holidays period?	The ITT is scheduled for release on 30th June to avoid peak holidays. Timeline will be kept under review,but early mobilisation is essential to meet delivery targets
22/May/25	What questions are expected to be in by the 28 May period? instead of the 2 June?	28th May is the deadline for clarification questions, Full RFI responses are due by 2nd June
22/May/25	Are you expecting the partner to build a front-end application, or focus purely on backend data modelling and standards?	Both. The solution must support data interoperabilityand user accessibility. This includes frontend aand backend functionality as part of the data product
22/May/25	Does this system replace the existing MAGIC system?	Not necessarily. Existing tools like MAGIC will be assess during Alpha. If they meet the requirements, they may be used or enhanced
22/May/25	Will the product be open source? Or will this be internal to government bodies only?	This will depend on findings from Alpha and discussions with Chief Data Office and Geospatial Commission. Broader government and public access is being considered
