Stand Build Regulations

Minimum area required for a Space Only Stands: 18m²

Stand Build Design

You are required to submit the required documentation to design and build custom stands to a nominated area of floor space. Stand designs must be submitted in a timely manner, in order for them to be reviewed and approved by ABHI.

All stand build designs must be submitted to ABHI for review an approval before 6th November 2024. ABHI reserve the right to refuse any designs, or request amendments to designs, which in their opinion have a detrimental effect to neighboring exhibitors or the overall look of the ABHU UK Pavilion.

Height Limits

Should there be a neighboring stand(s), dividing wall must be within 2.4m height limit. Any structure higher than 2.4m must seek approval by ABHI

Walling

Long runs of walling must be avoided along sides open to gangways. Only 50% of any open side to an aisle can be constructed with solid walling or fixings – 50% must be accessible. The only exception to this is 100% clear paneling or glazing.

Exhibits and walling should be positioned in such a way as not to obstruct the view of the exhibition or adjacent stands and ABHI reserve the right to refuse any designs, or request amendments to designs, which in their opinion have a detrimental effect to neighboring exhibitors or the overall look of the exhibition.

Where the stand is adjacent to another, a dividing wall between your neighboring stand <u>must be built.</u> The height restriction for a dividing wall is 2.4m.
