#### Special Term 5:

The Deliverables are for Buyer's exclusive use and provided for the purposes described in this Call-Off Contract. No person other than Buyer may rely on the Deliverables and/or information derived from them. This does not affect the Buyer's right to sub-licence any New IPR or Specially Written Software that may be supplied under the Call-Off Contract.

#### Special Term 6:

The Supplier may decline any aspect of the proposed scope and methods of a Buyer's security and/or audit requirements on the basis that it:

- includes any technical vulnerability or penetration testing of the Supplier's system; and/or
- may potentially breach Supplier's client confidentiality obligations; and/or
- is outside the scope of services provided to the Buyer under the Call-Off Contract.

#### Special Term 7:

Any information relating to: personal information (CV's, contact details etc.); pricing and details of Supplier's cost base; insurance arrangements; proprietary information; and/or approach and/or methodologies, is commercially sensitive/confidential and exempt from disclosure and publication under the Freedom of Information Act 2000 ("FOIA"). Buyer will be able to provide accurate and up to date documentation and data, such as technical artefacts, financial information to support option costing, etc. to support options analysis, development and costings, supplying this in a timely manner and supportive of the timescales to achieve the statement of requirements
