### **CONTRACT NUMBER: PO 7578**

1. With reference to the contractual letter dated 30 June 2016 as most recently amended by the letter dated 13<sup>th</sup> September 2018 your firm was engaged to undertake the Services described at Section 3 Terms of Reference, I confirm that the UK Government wishes to make the following further amendments to the letter of 30 June 2016:

**Section 1, Financial Limit: Delete:** £30,000,000 and **INSERT:** £32,470,000.

### **Section 3 – Terms of Reference:**

- ii. **INSERT:** Appendix A: Schedule of Processing, Personal Data and Data Subjects.

### **Section 2 – Standard Terms and Conditions: **\*\*redacted\*\*****

2. This amendment relates to COVID 19 related activity only, where services will:
  - o secure and strengthen the logistics system to protect the supply and distribution of essential bulk commodities.
  - o provide logistics support for securing essential health supplies (such as medicines and protective equipment).
  - o Deliver diagnostics and advisory support aimed at mitigating and responding to the current crisis in the field of logistics and other crucial functions of Ethiopia's economy.
  - o Due to this COVID 19 activity being delivered remotely, the expenses percentage charge has been reduced **\*\*redacted\*\***. This reduction relates to the activity outlined in this amendment only.
3. Please confirm in writing by signing and returning one copy of this letter, within **15 working days** of the date of issue that you accept the amendments set out herein.
4. Please note the provision in the contractual letter that the financial limit of the UK Government's liability to



the Supplier under this engagement shall not exceed the sum specified unless the amount of any such excess has been agreed by the Department for International Development in writing before the Supplier takes any action which might result in the financial limit being exceeded.
