External Personnel Doors:

Personnel steel doors, outward opening, with level access thresholds in accordance with APD M of the building regulations, with Briton Mortice Sash lock with Stainless Steel Handles, (Panic Fire Exit Bar internally) low profile DDA Threshold, powder coated with textured finish. Leaf constructed from 1.2mm Roll formed Rustec Steel. Filled with a Honeycombe Core for extra attack resistance. Frame constructed from 1.6mm Roll formed Rustec Steel. Expanding frame with 12 fixing points as standard. Integrated anti jemmy strip with lock protection system. Three stainless steel hinges with anti-jemmy studs.
