#### Definitions

1. For the purpose of this Agreement and in addition to the terms defined in the Specific Terms the following words shall have the following meanings:

#### "Footage"

audio-visual material taken from the coverage of the Competition(s); and

#### "Party(ies)" UEFA and/or the Licensee.

#### Grant of rights

2. UEFA grants to the Licensee during the Term in the Territory, the non-exclusive right to use a number of minutes of the Footage equivalent to the Duration to be included in the Product in the Formats only. The right to exploit the Footage within the Product is limited to (i) the Language(s) and to (ii) the Number of Units. Unless otherwise envisaged by this Agreement, such Footage shall be obtained by the Licensee from any third party of its choice at its own expense.

3. The Licensee undertakes that it has no right to use the Footage otherwise than exclusively in the Product for exploitation in the Format(s). All other media support including without limitation other formats or Internet webcast, television broadcast as well as transmission via mobile wireless technology are excluded. Therefore, in the scope of this Agreement and without limitation to the foregoing the Licensee is not allowed to use the Footage for advertising or commercial purposes.

4. UEFA does not grant match commentary rights.

5. The Licensee acknowledges and agrees that the Product will not be sold outside of the Territory, and/or released/distributed/sold before (a) the Date of First Release and (b) having been fully approved by UEFA in accordance with the terms of this Agreement.

6. The Licensee acknowledges and agrees that, save to the extent of its express rights hereunder all rights to exploit the Footage belong to UEFA. Furthermore, all rights not expressly mentioned and/or granted in this Agreement are excluded, retained by and rest the sole and exclusive property of UEFA.

7.1 The rights and obligations of the Licensee under this Agreement are personal to the Licensee and may not be assigned, transferred, sub-licensed, sub-contracted, sold or otherwise disposed of unless otherwise agreed in advance in writing by UEFA. 13.
