INSERT: 'Payments under this Contract shall not, in any circumstances, exceed **£28,228,748** exclusive of any government tax, if applicable (the "Financial Limit"), of which **£4,553,751** is in respect of fees and expenses under the terms of this Contract as detailed in section 5 Annexes A and B and the balance of the Financial limit of **£23,674,997** is the funds available for project financing as detailed in the Terms of Reference'
