Section 1 - FORM OF CONTRACT

CONTRACT FOR : **Technical Assistance and Support for UK-India Economic Policy and Prosperity Partnership (EPPP) Programme**

PURCHASE ORDER NUMBER : **PO 7496**

THIS CONTRACT is made

BETWEEN : The Secretary of State for International Development at the Department for International Development, Abercrombie House, Eaglesham Road G75 8EA ("DFID");

AND : PricewaterhouseCoopers Pvt. Ltd ("Supplier")
whose principal place of business, or, where the Supplier is a company, whose registered office is situate at
Plot No. Y-14, Block –EP, Sector –V, Salt Lake, Kolkata – 700091, India

(together "the Parties").

WHEREAS:

- A.** DFID requires the Supplier to provide the services as defined in Section 3 (the "Services") to DFID India and the Government of India's Ministry of Finance Department (the "Recipient"); and
- B.** the Supplier has agreed to provide the Services on the terms and conditions set out in this Contract.

IT IS HEREBY AGREED as follows:

1. Documents

This Contract shall be comprised of the following documents:

Section 3	Terms of Reference
Section 4	Special Conditions
Section 5	Schedule of Prices

This Contract constitutes the entire agreement between the Parties in respect of the Suppliers obligations and supersedes all previous communications between the Parties, other than as expressly provided for in Section 3 and/or Section 4.

2. Contract Signature

If the Original Form of Contract is not returned to the Contract Officer (as identified in Section 4) duly completed (including the applicable Purchase Order Number at the top of Section 1), and signed and dated on behalf of the Supplier within **15 working days** of the date of signature on behalf of DFID, DFID will be entitled, at its sole discretion, to declare this Contract void.

No payment will be made to the Supplier under this Contract until a copy of the Form of Contract, signed on behalf of the Supplier, is returned to the Contract Officer.

3. Commencement and Duration of the Services

The Supplier shall start the Services on 23rd September 2016 (the "Start Date") and shall complete them by 22nd September 2020 (the "End Date") unless this Contract is terminated earlier in accordance with its terms and conditions.

4. Financial Limit

Payments under this Contract shall not, in any circumstances, exceed £2,652,486.00 exclusive of any government tax, if applicable (the "Financial Limit").

This includes £522,991 which has been ring-fenced to account for the provision of the Policy Advisory Team as described in Section 3: Terms of Reference (para 3.3b). A further £562,500 has been ring-fenced to account for the provision of the General Resource Pool, as described in Section 3: Terms of Reference (para 3.3c).

5. Time of the Essence

Time shall be of the essence as regards the performance by the Supplier of its obligations under this Contract.
