1 Background/Introduction

- 2.2 To be able to provide software for controlling geotechnical equipment, CPT, Vibrocorer, Thermal and winches as per Feritech designs.
- 2.3 Willing to sign an NDA (Non-disclosure agreement), and receive confidential FT500 design information.
- 2.4 The software supplied should be able to be used on touch screen tablet.
- 2.5 Controlling of multiple types of equipment including on board and sub sea equipment.
- 2.6 The software should be able to create detailed configuration files.
- 2.7 The software should be able to be used to create accurate graphs and data.
- 2.8 The supplier should be familiar with the Feritech Hub software.
