Subcontract Scope

Section 1: Project & Contract Information

Contract Information

The National Highways RDP Framework Contract is a £8.7 billion programme for improving its road network across England. The contract, developed under the Routes to Market programme, provides incentives for companies to produce better outcomes under the contract, including:

• Shorter duration and more accurate management of roadworks to help drivers better plan their journeys and experience predictable journey times.

- Buying more efficiently and buying locally using the capability of a region to benefit the region.
- Encouraging innovation, for example lighting and signs designed to need less maintenance, reducing disruption and improving road worker safety.
- Reduced road noise and increased environmental benefits.

The work is arranged into 18 Packages of schemes, awarded to Delivery Integration Partners in bands of up to \pounds 100m (lots 1 to 3) and over \pounds 100m (lots 4 to 8). Keltbray is part of Lot 3, which is for the delivery of packages of work and standalone schemes with an estimated value up to £100m. Lot 3 schemes will be in the Yorkshire and the Humber, Northeast and Northwest regions.

Project Information

The A66 plays an essential role for journeys across the north of England and provides the most direct route between the central belt of Scotland and the eastern side of England. The route connects cities like Glasgow and Edinburgh with Leeds, Sheffield and Norwich. It's a critical route for freight, providing links to several international ports like Stranraer, Hull and Felixstowe and connects holiday makers to their destination, whether that be in the Yorkshire Dales or Lake District.

The A66 plays an important role in the life of nearby communities, connecting people to jobs, education, health and other essential services. Sections of the road are not up to modern standards. It repeatedly widens and narrows, making it prone to congestion and delay. National Highways are proposing to deliver one billion pounds worth of investment to dual the remaining single carriageway sections along the 50 mile stretch of the A66 between Cumbria and North Yorkshire.

This is one of the largest and most important highways investments in the north of England, and will significantly improve journeys, safety and connectivity.

Keltbray

The preferred route was announced in January 2021 after Amey Arup completed stage 2 of the National Highways Project Control Framework (PCF) stage. Stage 4 (preliminary design) was awarded in August 2022 and is scheduled to run to December 2023. PCF 5 (detailed design) and 6 (construction) are to now be delivered by Keltbray. Stage 6 is aligned to start in March 2024 to satisfy the National Highways funding strategy.

Keltbray has been appointed as the Delivery Integration Partner (DIP) for the Penrith to Temple Sowerby section highlighted above (Section ref. 3a). The scope is summarised as follows;

- Widen the route to dual carriageway between Penrith and Temple Sowerby on this section, providing
 more capacity. The scheme predominantly follows the old route. It would involve widening the old A66 to
 form one side of the new dual carriageway. The second carriageway would be constructed to the north
 of the existing route
- Improve access to St Ninian's Church on the Winderwath estate with a new left-in, left-out junction and relocation of the existing car park
- Provide access to the local road network with the introduction of a new left-in, left-out junction at the B6262.
- New accommodation bridge structure at Brougham to enable access over the A66
- New accommodation underpass at Whinfell to enable access under the A66.

Section 2: Description of subcontract works

The *Subcontractor* is responsible for providing all labour, supervision, plant, materials, equipment and temporary works to complete the provision of pavements installation.

This is inclusive but not limited to;

- A planer is required to carry out planing works on each access road. All arisings are to be left on site.
- Allowance for hand lay as required.
- Plating over iron work.
- The Subcontractor has taken into consideration any overhead services which will affect their method of working
- Step / joint details are to be installed in accordance with the Manual Of Contract Documents For Highways Works Volume 1 Specification For Highways Works - Series 900 Road Pavements – Bituminous Bound Materials
- A copy of any regulating tickets must be provided by the *Subcontractor* to the *Contractor* as soon as possible (no later than the next working day) the material which has been delivered.
- All 'dips' must also be jointly recorded, agreed and signed with the *Contractor* during the same shift. No claim for any regulating will be accepted without these signed records.
- Delivery records are to be provided by the *Subcontractor* as soon as possible (no later than the next working day) for *Contractor* sign off/approval. These are to contain the following minimum level of information: specification of material, dispatch on-site/discharge off-site times, temperature records at point dispatch and discharge.
- Subcontractor is to provide as soon as possible (no later than the next working day), a laying record which identifies where each load (identified by delivery records above) of material has been installed.
- Banking of material wagons to, from and around the site.
- All temporary works necessary to provide the works.
- Planing operations may be in the vicinity of existing services, *Subcontractor* is responsible for working around such services.
- No facilities/attendances/equipment will be provided by the *Contractor*, except as indicated within Section 3: Attendances within the Subcontract Scope
- Wastage of and damage to permanent/temporary materials will be monitored and the *Contractor* reserves the right to re-charge the *Subcontractor* for any extent of wastage/damage.
- Protection of any building, permanent works, existing highway/footpath infrastructure, third party apparatus and the like, which is to be in place before the *subcontract works* commence.
- Provision of all Personal Protective Equipment (PPE) including but not limited to eye protection, safety helmet, high visibility vest, high visibility trousers, safety boots (not rigger boots) and gloves all to be in accordance with Client requirements and provided by the *Subcontractor* at its cost (and is included in the *Subcontractor's* rates). PPE must be orange.
- Road build-up to be installed in accordance with PT2b in Schedule 3 of Series 0700 Specification
- The Subcontractor must comply with all planning conditions
- Compliance with specification Scheme 03a: Centre Parcs West Penrith to Temple Sowerby (River Eamont to Whinfell Park) 0700 Series Specification Appendices, Document No: HE615323-JAC-HPV-03A_AL_SCHEM-SP-CX-000003, Revision P01.
- All Subcontractor personnel to have National Highways Passport. Also required to attend common induction and provide in date safety critical medicals for all resource attending site. All to be obtained at the Subcontractor's cost and deemed included in its Prices.
- Security of Subcontractor's Equipment

The *Subcontractor* has allowed for all setup, start and end of shift meeting, reporting and any other requirements within the tendered total of the Prices. The *Subcontractor* has allowed for all unproductive time for inductions, drugs and alcohol testing, medicals, approvals, permits, briefings, tool box talks and safety stand downs.

Section 6: Cleanliness of roads

The *Subcontractor* shall maintain cleanliness of their working area on Site. The *Subcontractor* is to provide a road sweeper to ensure tidiness of site is maintained.
