 (“**the Commissioners**”);

and

(2) **Anglia Ruskin University Higher Education Corporation** of Bishop Hall Lane,

Each a “**Party**” and together referred to as “**the Parties**”.

BACKGROUND:

(A) The Commissioner and the Provider entered into a contract entitled “Professional Nurse Advocate (PNA) Training Programme” on 9th August 2023 (“**the Contract**”).

(B) The Commissioner and the Provider have mutually agreed to vary the Contract for Professional Nurse Advocate (PNA) Training Programme as detailed below in (2) Contract Variation.

(C) The Commissioner will make payment to the Provider as detailed below (3) Costs / Schedule 3 - Payment.

IT IS AGREED as follows:

1. Definitions and Interpretation

- Capitalised words and phrases in this Variation Agreement shall have the meanings given to them in the Contract.
- The Contract, including any previous Variations, shall remain effective and unaltered except as amended by this Variation.

2. Contract Variation:

- In accordance with Clause GC13 (Variations) of General Conditions, the Contract the Commissioner and Provider have mutually agreed to the vary the contract as outlined below.
- Variation is to increase the number of places between the existing Contract Term (12 September 2023 – 31 March 2024) as outlined below.
