AGREEMENT OF VARIATION No. 2

relating to the supply of Services under a contract C262281 dated 18th April 2024



THIS AGREEMENT is signed and dated as per the signatory information on page 7 (the "Agreement") BETWEEN:

- (1) The Secretary of State for Health and Social Care as part of the Crown through the UK Health Security Agency of 10 South Colonnade London E14 4PU (the "Authority"); and
- (2) Cepheid UK Limited, a company registered in United Kingdom whose registered office is at Oakley Court Kingsmead Business Park, Frederick Place, High Wycombe, England, HP11 1JU (the "Supplier"), together the "Parties" and each a "Party".

BACKGROUND:

A. The Authority and the Supplier are Parties to a contract for the supply of maintenance and care of Cepheid system assets dated 18/04/2024 (Atamis Ref C262281) through the National Microbiology Framework Agreement for the supply of Goods and Services (the "Contract").

NOW THEREFORE, IT IS AGREED AS FOLLOWS:

1 TERMS DEFINED IN THE CONTRACT

1.1 In this Agreement, unless stated to the contrary, terms defined in the Contract and used in this Agreement have the meanings set out in the Contract. The rules of interpretation set out in the Contract shall apply to this Agreement. References to the Contract shall mean the Contract as amended by the Previous Variations and from time to time thereafter.

2. VARIATION

2.1 With effect from the date of the Authority's signature of this variation, the Parties agree to amend the Contract by:

A) deleting

1.3.1. The maximum value of the Services that can be ordered under this Contract shall be thirty-six thousand, three hundred and forty-two pounds and zero pence only (£36,342.00) (the "Contract Price").

replacing

1.3.1 The maximum value of the Services that can be ordered under this Contract shall be £81,817.58 (eighty-one thousand, eight hundred and seventeen pounds and fifty-eight pence) only (the "Contract Price").

- 2.3 Except as set out in Clause 2.1 of this Variation Agreement, the Contract shall continue in full force and effect.

3. THIRD PARTY RIGHTS

3.1 A person who is not a Party to this Agreement shall have no right under the Contracts (Rights of Third Parties) Act 1999 (as amended, updated, or replaced from time to time) to enforce any of its terms but this does not affect any third party right which exists or is available independently of that Act.

4. GOVERNING LAW AND JURISDICTION

- 4.1 This Agreement, and any dispute or claim arising out of or in connection with it or its subject matter (including any non-contractual claims), shall be governed by, and construed in accordance with, the laws of England and Wales.
- 4.2 The Parties irrevocably agree that the courts of England and Wales shall have non-exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this Agreement or its subject matter.
