## Specification of requirements

Epimorphics Ltd host, maintain and support a number of critical data services for the FSA, as part of the FSA data platform.

The FSA requires a continuation of the existing hosting and managed support of the following FSA Data Services:

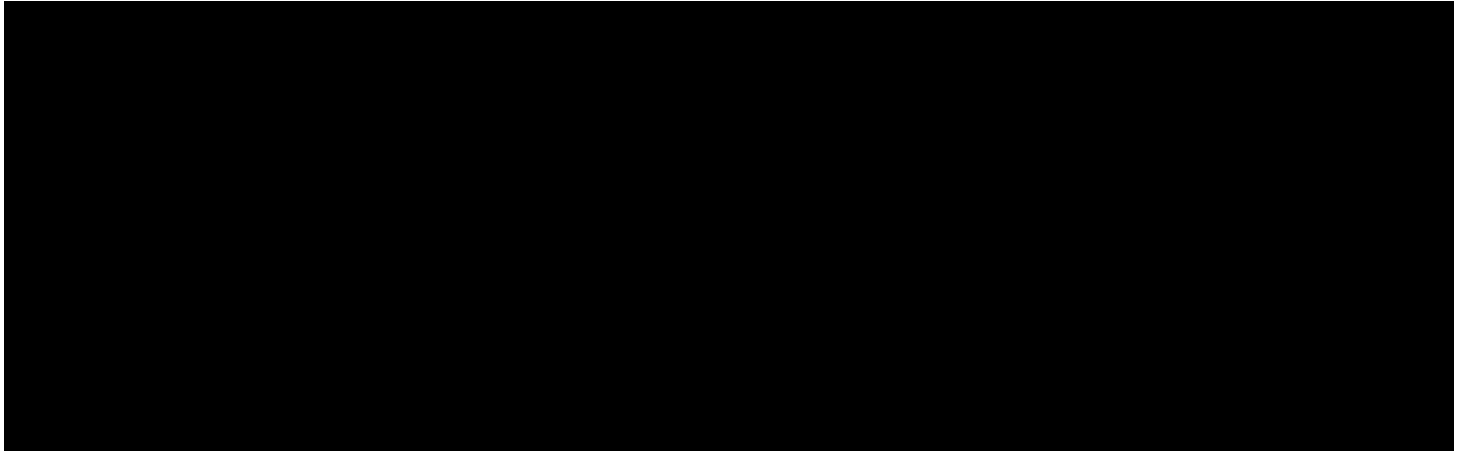
1. the overarching Data Platform (including Proxy and DNS)
2. the Data Catalog and Editor ([data.food.gov.uk/catalog](http://data.food.gov.uk/catalog))
3. the Codes (Registry) ([data.food.gov.uk/codes](http://data.food.gov.uk/codes)) and specialised FoodEx2 registry ([data.food.gov.uk/codes/ui/about-foodtypes](http://data.food.gov.uk/codes/ui/about-foodtypes))
4. the Food Alerts API and Editor ([data.food.gov.uk/food-alerts/editor](http://data.food.gov.uk/food-alerts/editor))
5. the Unified View - UI, API, SQL Connector and Data Store ([internal-data.food.gov.uk](http://internal-data.food.gov.uk))
6. the Regulated Products Register ([data.food.gov.uk/regulated-products](http://data.food.gov.uk/regulated-products))

Data Services Support is to be comprised of:

1. Hosting - The services are hosted on Amazon Web Services (AWS) in a dedicated area for the FSA. Hosting charges will be passed on to the FSA as monthly in arrears as expenses (*as per the GCloud12 FSA735 Contract*). In addition, the FSA would look to reserve appropriate server instances as to minimise overall costs through the annual support period. AWS charges would comprise of bandwidth, load balancing, server usage (reserved and unreserved) and storage.
2. Support - This is per service, per month fees for the maintenance and security patching of the named services with the addition of support components as specified in the Epimorphics FSA / GCloud default service arrangements document.
3. Annual licence for the Data Platform / Data Management Service components
4. In addition, the work package will contain some technical uplift components to continue a set of required changes, to align with longer term FSA needs, and to re-align the services into the newer DevOperational environment. These would be delivered monthly in arrears as a rate card based time and materials based activity.
