1.1 The Supplier shall take out and maintain, or procure the taking out and maintenance of the insurances as set out in the Annex to this Schedule, any additional insurances required under an Order Contract (specified in the applicable Order Form) ("**Additional Insurances**") and any other insurances as may be required by applicable Law (together the "**Insurances**"). The Supplier shall ensure that each of the Insurances is effective no later than:

- 1.1.1 the DPS Start Date in respect of those Insurances set out in the Annex to this Schedule and those required by applicable Law; and
- 1.1.2 the Order Contract Effective Date in respect of the Additional Insurances.

1.2 The Insurances shall be:

- 1.2.1 maintained in accordance with Good Industry Practice;
- 1.2.2 (so far as is reasonably practicable) on terms no less favourable than those generally available to a prudent contractor in respect of risks insured in the international insurance market from time to time;
- 1.2.3 taken out and maintained with insurers of good financial standing and good repute in the international insurance market; and
- 1.2.4 maintained for at least six (6) years after the End Date.

- 4.1.3 ensure that all workers are provided with written and understandable Information about their employment conditions in respect of wages before they enter employment and about

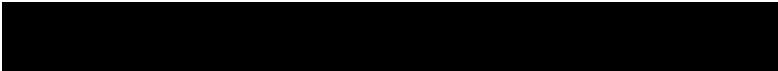

2. Complying with security requirements and updates to them

If the Security Management Plan is not Approved, the Supplier shall amend it within ten (10) Working Days of a notice of non-approval from the Buyer and re-submit to the Buyer for Approval. We work with local, national, and international regulators, with consumer representatives and with businesses to deliver effective protections and to support compliance.</p> <p>We are responsible for the regulation of most consumer goods (excluding food, medicines, and vehicles) and we are the national regulator for construction products. We hold policy responsibility for product safety, legal metrology (weights and measures), standards and accreditation, hallmarking, and <u>Primary Authority</u>.</p> <p>We act to keep citizens safe by keeping products safe. We seek to ensure consumers receive fair measures and get what they pay for. We work to limit the negative effects that products, their supply chains, and their disposal can have on our environment. OPSS values data to inform its decision-making processes and has committed to utilising relevant data wherever possible, to improve our ability to protect people and places from product-related harm and ensure consumers and businesses can buy and sell products with confidence.

The main aim of this exercise is to establish the construction product data landscape, identifying data sources that OPSS may benefit from in the wider context of product regulation and incident prevention, set out how identified data sources could provide helpful insight into construction product regulation and recommending which should be acquired to benefit organisational priorities.

We currently have access to various data sets, see the section “Background to the Requirement” below. We want to understand, should this fail to present the full picture of available data, whether there is data that we could utilise to further inform our activity, being these domestic or international data.

The purpose of this specification is to set out the scope of the Services that the Supplier shall provide.

Background

Several factors led OPSS senior leadership team to recognise the necessity of the exercise. The recently completed data strategy highlighted the valuable role data plays in enabling OPSS to achieve its strategic outcomes, in particular, how actively using data products enables informed choices especially in terms of regulatory intervention.

The data strategy also highlighted the need to sharpen understanding of the regulatory landscape and key actors, through the acquisition and development of data sources and reviewing legal obligations for information notifications under relevant legislation, even beyond already acquired and analysed databases.

The National Data Strategy identified a number of interconnected issues currently prevent the best use of data in the UK:

- **Data foundations:** The true value of data can only be fully realised when it is fit for purpose, recorded in standardised formats on modern, future-proof systems and held in a condition that means it is findable, accessible, interoperable and reusable. By improving the quality of the data, we can use it more effectively, and drive better insights and outcomes from its use.
- **Data skills:** To make the best use of data, we must have a wealth of data skills to draw on. That means delivering the right skills through our education system, but also ensuring that people can continue to develop the data skills they need throughout their lives.

- **Data availability:** For data to have the most effective impact, it needs to be appropriately accessible, mobile and re-usable. That means encouraging better coordination, access to and sharing of data of appropriate quality between organisations in the public, private and third sectors, and ensuring appropriate protections for the flow of data internationally.
- **Responsible data:** As we drive increased use of data, we must ensure that it is used responsibly, in a way that is lawful, secure, fair, ethical, sustainable and accountable, while also supporting innovation and research.

In applying the four pillars of challenge from the National Data Strategy to OPSS, we have identified the following issues. We note many of these challenges are widely applicable to regulators and we will work closely with other regulatory agencies both to learn from, and to share our own experiences.

- The complexity of regulated sectors in terms of the number of actors, differing operating models, legal responsibilities and incentives .
- Information asymmetry often occurs due to complexity of product design manufacture which needs correction through regulatory intervention .
- The changing nature of consumer behaviour and the diversity of need
- The regulatory regime has few touch points between the regulator and regulated entities (such as registration or licensing) which limits data collection .
- The limited availability of regulatory data can lead to an overreliance on partner or third party data .
- There can be issues of trust and a lack of incentive for industry to voluntarily report information that can assist in building better pictures of emerging issues .
- Systematic legal, cultural and technological data sharing challenges, including the lack of common data standards and poor data quality.

We wish to develop our data maturity as an organisation – identifying data gaps, improving data exchange and embedding data into our decision-making processes across our policy and regulatory functions to enable us to better deliver our organisational outcomes.

The Data Transformation Programme, which resulted from the Data Strategy, highlighted the need to identify new priority data gaps for product safety and construction products, as well as a process for identifying, acquiring, and filling data gaps on an ongoing basis.

The work done so far includes:

- The release of Research and Data Library to OPSS staff on 22/06/22. A single signposting location that provides an inventory of finished or published work currently available to OPSS. It is built using Microsoft Lists and addresses the barrier to finding and accessing data by listing in a single place the key research and data that OPSS holds or has access to. This included clarifying data owners and linking to a list of MoUs.
- A Data Quality log developed, forming the basis for the collection, prioritisation and fixing of data quality issues.

- Automated reporting using PSD data on Power BI is being trialled. This will provide a template and learning for the automated reporting of other data and inform the development of the data hub. It has also highlighted data quality issues to be fed into the Data Quality Log.
- Commissioning of a Data Architect, to carry out Data Architecture discover.
- The use of product taxonomy to determine new enquiries case management system (ECMS) categories.
- Establishment of a network of internal data owners, contacts and main stakeholders documented (part of establishing data governance framework).
- Establishment of the Data User Group to agree priorities around data quality and accessibility.

The data we hold:

Industry data and reports

- GfK Construction Products [Subscribed, no foreseeable renewal] – An external market research company that offers reports on several industries. On construction products, GfK makes two datasets available: the Total Store Report, Building (TSR Building) and the GfK Reporting Interactive Dashboard (GRID). The former cover macro trends of broad construction products categories, the latter tracks trends for specific categories ('Bricks' and 'Insulation materials' to data) in details, covering units, value, materials, brands, and type of products. The source is electronic point-of-sales data from a panel of large non-specialist merchants. The datasets claim to cover 82% of generalist builders' merchants' sales and up to 45% of the market.
- Mintel Market Research [Subscribed] - An external market research company that offers reports on the construction industry as well as specific construction products. Their primary research, that includes estimation of market size and trend analysis, is helpful for market mapping and subsector analysis. The company uses both primary research and secondary data from government and trade associations, again these are indicated in the specific reports.
- AMA Research– An external market research firm who produce several market reports on the construction products industry. The most prominent of which this is the Construction Sectors, Contractors & FM. Each report is bespoke, with a varied mix of data about the industry, forecasts, suppliers, and distributors. The reports can be used to scout for data within a specific sector. The company is part of Barbour ABI.
- Glenigan- An external market research company providing a series of indicators of construction industry performance in the UK and offers a summary of market trends, challenges, and opportunities. The main report is the Construction Industry Performance Report. It includes key performance metrics and consolidated data.
- Adroit Market Research - It produced for the Ministry of Housing, Communities and Local Government (MHCLG) the Construction Products Industry Market Assessment. The report analysed the scale and nature of construction products industry in the UK, including imports and exports.

- Supply chain reports - This report involves the collection of information from key stakeholders across the UK through questionnaires, interviews, focus groups and workshops. The final product is a consolidation of several (5) construction products' supply chains analyses. The report also provides insight into the technical information data flows between each tier of the supply chains process, including quality assurance processes.
- Marketline – A private research company that develops market intelligence reports. The company works across multiple industries and undertake bespoke projects on top of off-the-shelf reports. For the construction industry, their work is based on the construction market overall and cover a global perspective.

Industry platforms

- National Building Specification (NBS) - An integrated global platform bringing together firms involved in the design, supply, and construction of the built environment. The platform developed a series of interesting tools such as the 'Uniclass', a dynamic and unified classification system for the construction industry covering all sectors, that the platform maintains and updates; or the 'NBS Source', a tool that creates a single source for product information.
- CoBuilder – The company offers an IT platform that employs all relevant international standards for data management to help construction industry actors exploit the potential of product data. Fit-for-purpose and accurate product data improves quality of service, time to market and reduces time, cost, and environmental footprint.

Government data and statistics

- Statistics of Building Materials and Components [Open Source]– A ONS highly detailed publication that tacking major construct product areas and providing insights into price indices, sales, and international trade trends. Good for market mapping. The Department of Business and Trade (DBT) prepares and distributes monthly bulletins.
- Construction Statistics [Open Source] - A ONS mothy and yearly publication on the construction industry, including value of output, new orders by sector, number of firms and total employment, insolvencies and construction Output Price Indices.
- English Housing Survey [Open Source] - A continuous national survey commissioned by the Department for Levelling Up, Housing and Communities (DLUHC). It collects information about people's housing circumstances and the condition and energy efficiency of housing in England.

- **Economic Impacts of the Construction Products Regulation (EU Report) [Open Access]** - An EU-wide consultation with individual construction products manufacturers and distributors, as well as European associations representing professional and private end-users. It has collected both qualitative and quantitative data on the costs and benefits of construction products regulation.
- **Hackitt Review** - An independent review of building safety regulations. Written after the Grenfell Tower fire, this report identifies that the current system of building regulations and fire safety is not fit and highlights a need for cultural change. The new framework describes a stronger oversight of duty holders with incentives for right behaviour and effective sanctions for poor performance, setting out principles for a more effective testing regime that calls for clearer labelling and product traceability.

Government regulations references

- **Harmonised European Standards, EU regulation (CPR 305/2011).** The standards provide a technical basis to assess the performance of construction products. They enable manufacturers to draw up the Declaration of Performance as defined in the Construction Products Regulation, and affix the CE marking. Harmonised standards have been taken over after Brexit. The Standards make enforcing regulation easier, at least against covered products. Standards impose manufacturers to declare standard adherence, according to a test and declare practice. Good data is collected. However, not all products are covered by the regulation and no or poor-quality voluntary data is collected.
- **The Code for Construction products Information (CCPI).** The code of conduct helps organisations derive higher standards in the presentation of construction products information (i.e., information needs to be clear, accurate, up-to-date, accessible and unambiguous). OPSS backs the CCPI, but the adherence to it remains voluntary.

Building Safety Bill - A bill explaining the government's commitment towards fundamental reform of the building safety system, published in April 2020. It is backed by recommendations and principles described in the Dame Judith Hackitt's Independent Review of Building Regulations and Fire Safety report. It outlines how plans are underway for greater accountability and responsibility for fire and structural safety issues, by establishing a new Building Safety Regulator.
