Reason For Award of Contract: It is considered that the existing contract with Leonardo UK Ltd can be amended for technical reasons. The Original Equipment Manufacturer (OEM) Leonardo retains the proprietary rights to design and manufacture the M428 Identification of Friend or Foe (IFF) system. This specific model of IFF is required to be issued by the Authority to Atlas Elektronik UK Ltd as Government Furnished Equipment, as an element of the current phase of the UK SWEEP Contract. The integration of the M428 is critical to ensure that the UK SWEEP system has commonality, compatibility and interoperability with the Royal Navy and wider UK Armed Forces, which currently operate using the same IFF system.

Value of Contract: £320,000

Justification For Non-Competitive Decision: There is a strict technical impracticality for any other economic operator to undertake the work required within this contract, as this specific model of IFF system is proprietary to Leonardo, and is congruent with previous IFF equipment purchased for the UK SWEEP Programme. This model of IFF system is necessary for interoperability, compatibility and commonality purposes, in order to successfully integrate into the current systems operated by the Royal Navy and wider UK Armed Forces. An alternative IFF system provided by another economic operator would not provide sufficient compatibility, commonality and interoperability with the current IFF equipment in use by the UK Royal Navy and Armed Forces.
