With reference to the contractual letter dated 19th February 2014 as most recently amended by the letter dated 29 July 2015 whereby your firm was engaged to undertake the Terms of Reference as described in Annex A to the contract and with reference to your letters of 27th and 28th July 2015 and subsequent discussion, I confirm that the UK Government wishes to make the following further amendments to the letter of 19th February 2014:

Contract Covering Letter:

Para 1.1: Delete existing para and Insert new para as follows:

"The supplier shall start the Services no later than 1st March 2014 ("the Start Date") and the Services shall be completed by 1st March 2016 ("the End Date") unless the Call-Down Contract is terminated earlier in accordance with the Terms and Conditions of the Framework Agreement."

Para 3.1 - Financial Limit : Delete existing para and Insert new para as follows :

" Payments under this Call- Down Contract shall not exceed £2,234,591 ("the Financial Limit") and is exclusive of any Government Tax, if applicable as detailed in Annex B."
