2. **Agreement Signature**

If the Original Form of Contract is not returned to the Contract Officer duly completed (including the applicable Purchase Order Number at the top of Section 1) and signed and dated on behalf of the Supplier within 15 working days of the date of signature on behalf of FCDO, FCDO will be entitled, at its sole discretion, to declare this Agreement void.

No payment will be made to the Supplier under any Call Down Contract until this Form of Agreement and the relevant Call Down Contract, are signed on behalf of the Supplier, and returned to the Contract Officer.

3. **Commencement and Duration of Agreement**

The Agreement shall commence on 18 December 2023 (the "start date") and shall expire on 17 December 2025 (the "end date") unless this Agreement is terminated earlier in accordance with its Terms and Conditions.

4. Time of the Essence

Time shall be of the essence as regards performance by the Supplier of its obligations under this Agreement and each Call Down Contract in existence from time to time.

5. **Use of Agreement**

Other Contracting Authorities (e.g., UK Government Departments and any other donors of development funding) can make use of the arrangements under this Agreement.
