Special Term 1: Reimbursement for Expenses and Disbursements The Buyer shall only be liable to reimburse the Supplier for expenses or disbursements that are:

- (i) specified in this Contract; or
- (ii) approved by the Buyer prior to the Supplier incurring such expenses or disbursements. The Supplier shall not invoice the Buyer for any other expenses or disbursements.

#### Special Term 2: Contract Year 2 Negotiations

The Parties shall meet a reasonable time before the expiry of the Call-Off Contract (31st October 2023, being the end of Contract Year 1), and in any event no later than 1st April 2023, to negotiate an extension to the Call-Off Contract using the Variation Procedure. In negotiating, the Parties shall have regards to the following (non-exhaustive) items: any operational changes to the Services, Actual and anticipated Call Volumes and any indexation applicable to the Supplier's costs of operating the Services. For the avoidance of doubt the Parties acknowledge and agree that the Authority's intention would be to reintroduce binding Service Levels and Service Credits and utilise the standard provisions in the Call Off Schedules and Joint Schedules as a starting position. In the event that the Parties are unable to agree an extension on terms for Contract Year 2 by 30th April, then either party may serve a formal written notice to the other party to terminate the Agreement without further liability provided that such notice shall be served no later than 14th May 2023. Upon service of such notice the Agreement shall naturally expire on 31st October 2023.

#### Special Term 3: Right to Terminate

The Buyer shall have the right to terminate this Contract on October 31, 2023, if any of the following occur:

- (i) a change in departmental policy that results in the scheme no longer existing or undergoing a major overhaul that alters the operating model of the existing contract;
- (ii) a political change in the direction of the department;
- (iii) a change in budgets that supersedes the intended spend.

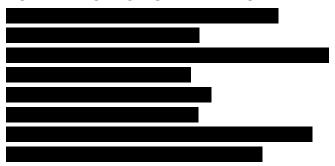
