With reference to the contractual letter dated 15th November 2010 (as most recently amended by the letter dated 25th September 2013) whereby your firm was engaged to undertake the services defined at Section 3 of the contract, and with reference to subsequent discussion, I confirm that the UK Government wishes to make the following further amendments to the letter of 15th November 2010:

Section 1 – Form of Contract

3. Commencement and Duration of the Services
