With reference to the contractual letter dated 5<sup>th</sup> November 2015 (as most recently amended by the letter of 5 April 2016) whereby your firm Price Waterhouse Coopers was engaged to deliver the Terms of Reference for the Good Governance Fund and with reference to your emails of 17<sup>th</sup> June, 12<sup>th</sup> July, 13<sup>th</sup> July 2016, 26<sup>th</sup> July 29<sup>th</sup> July and 1<sup>st</sup> August, I confirm that the UK Government wishes to make the following amendment to the letter of 5<sup>th</sup> November 2015:

## Section 4, Appendix A

## 3. Financial Limit

3.1

**Delete** "Payments under this call-down contract shall not, exceed £10,000,000 ("the financial limit") and is exclusive of any government tax, if applicable as detailed in Annex B"

**Insert** "Payments under this call-down contract shall not, exceed £20,000,000 ("the financial limit") and is exclusive of any government tax if applicable as detailed in Annex B"

Delete "This is a multi-year CSSF funded programme with year 1 funding identified only"

Insert "This is a multi-year CSSF funded programme with funding approved up to end of March 2017 only"

### 9. Sub Contract Terms and Conditions

"DFID and the supplier have agreed that the supplier's sub-contract with BBC Media Action will vary the standard DFID terms and conditions for Intellectual Property Rights (Clause 21) and The Official Secrets Act (Clause 26) in accordance with the suppliers proposal of 03 May 2016. This variation to DFID's standard terms and conditions is permitted within the suppliers sub-contract with BBC Media Action only."

#### CI 21 Intellectual Property

21.1 All intellectual property rights in all material (including but not limited to reports, data, designs whether or not electronically stored) produced by the Supplier or the Supplier's Personnel pursuant to the performance of this Agreement (the "Material") shall be the property of the Supplier or the Supplier's Personnel;

21.2. The Supplier hereby grants to DFID a perpetual, world-wide, non-exclusive, irrevocable, royalty-free licence (save in respect of payments due to collecting societies) to use all the Material.

21.3. For the purposes of Clause 21.2 "use" shall mean without limitation, the reproduction and publication of all the Material in full and the intellectual property rights therein to the extent permitted including the reproduction of the Material and products incorporating the same for use for the purpose of the Good Governance Fund Project.

21.4. DFID shall not have the right to sell or sub-licence the Material without the prior written permission of the Supplier's sub-contractor which is the BBC;

21.5 DFID acknowledge and agree that any use of data arising out of research findings and evaluations shall only be used in a way that maintains the anonymity of the person that such data relates to.

#### CI 26 Official Secrets Act

26.1 The Supplier may only disclose HMG's Confidential Information to its staff and sub-contractors who are directly involved in the provision of the Services and who need to know the Confidential Information, and shall ensure adherence to any additional safeguards required at the call off stage and will ensure that staff are aware of and shall comply with these obligations as to confidentiality and security classifications as necessary.
