OGP strategic requirements rely and need this software to produce data evidence and information for decision making.</p> <p>The bespoke nature of the e-PIMs legacy platform requires significant technical knowledge that the current Supplier has embedded through involvement in delivering the current capability for over 15 years. Programme experience means the Supplier understands ways of working of the technology partner (processes and system architecture), stakeholders and the business objectives.</p> <p>The current Contract ends on 31/03/22 hence this Variation 1 is required to extend due to timeframes and the ability to continue running the current system and outputs whilst the change programme for a new system is ongoing..</p>
