1.3 Statement of Requirement – Production and delivery of pre-planted coir mats and plug plants of specified wetland species

2. Time

2.1 The anticipated/planned *starting date* is:

Installation ready mats & plants required for delivery from w/c 20 March 2023. Must be delivered before 31 March 2023.

2.1 The *period for reply* to a communication is:

1 week

2.2 Contract Term:

Goods must be delivered before 31 March 2023

3. Risk and Insurance

- 3.1 The amount of the minimum limit of indemnity for insurance in respect of loss of or damage to property and liability for bodily injury to or death of a person (not an employee of the *Contractor*) due to activity in connection with this contract for any one event is £5,000,000.
- 3.2 The amount of the minimum limit of indemnity for insurance in respect of death of or bodily injury to employees of the *Contractor* arising out of and in the course of their employment in connection with this contract is £5,000,000.

4. Form of Contract and Conditions

- 4.1 The form of agreement is the Broads Authority Standard Supply of Goods Contract (available on request).
- 4.2 All communications and instructions between the *Contractor* and *Employer* are to be made through the *Project Manager*, or persons named by the *Project Manager*.

5. Supply Information

5.1 Specification

5.1.1 Pre-planted coir mats

- 250 x 2m x 1m coir mats, pre-planted with a mix of at least 60% *Typha sp.* and 40% *Phragmites australis*
- Minimum planting density of 10 plants per m² (20 plants per mat)
- Minimum plant height of 30cm on delivery

NB: Typha has been selected and prioritised owing to it being less susceptible to goose grazing. Alternative species mixes can be offered but will need justification and evidence of reduced palatability to geese.

5.1.2 Plug plants

- 11,500 x *Phragmites australis* 90cc maxi plug plants
- 3,200 x Typha angustifolia 90cc maxi plug plants
- Minimum plant height of 20cm on delivery

5.2 Delivery

Delivery to be from w/c 20 March 2023 and is likely to require a split load with two delivery locations in the Upper Thurne area (Horsey and Martham can be used to calculate delivery charges). Goods must be delivered before 31 March 2023.

5.3 Price

The Price List is to be based on the information and specification submitted by the Employer in Section 5.

6. Evaluation

6.1 Tender assessment and scoring

Evaluation of the returned tenders will be based on the following award criteria. For each criterion, a score from Table 1 will be awarded against the weighted delivery process category as shown.

As indicated in the table above, each of the award criteria will be weighted so that the contract will be awarded to the tender considered to be the 'most clear, economical and offering a complete service'.

6.2 Evaluation Criteria

The evaluation of the returned tenders will be based on a set of criteria (set out below). Tenders will be cored according to the evaluation in Table 2.

Evaluation will be undertaken when all tender submissions have been received as per the deadline specified in this document.

The pre-qualification elements (section 8) will be assessed on a pass or fail exercise. All numbered elements need to be passed for the tender to be considered further.

The successful tenderer's responses to the evaluation questions (section 11) will then be evaluated on a qualitative basis.

A panel of Broads Authority representatives will review the responses individually. Once the individual evaluations have been completed, the panel will discuss all scores and confirm an agreed score for each criterion for each supplier to give the final total score.
