Annex 1 – Outline of work.

Project purpose

Saint Helena (SH) and the Falkland Islands (FI) are UK Overseas Territories in the Atlantic. They are remote islands with limited socio-economic growth. There is a lack of evidence about the factors associated with mental health in adolescents living in LMICs (Low- and Middle-Income Countries) and remote communities and how resources and/or services support adolescents' mental health more effectively in LMICs and remote communities. Mental Health professionals in SH and FI that OHID works with have shared concerns that young people living there are likely to be at risk for psychological difficulties. However, local evidence is lacking which needs to be addressed.

Technology via internet and mobile use can offer input for mental health and wellbeing for people including those from LMICs and to those living in remote places.

Work is needed to identify the mental health needs of young people in SH and FI and develop an intervention that can be piloted in these communities. This study will help give a clearer understanding of the mental health issues amongst young people in SH and FI and provide an opportunity for a locally developed potential solution to be piloted. Information gained from this study will inform acceptability and feasibility of an App to promote resilience and psychological well-being on SH and FI and other remote UK Overseas Territories.
