In accordance with Clause 32, VARIATION PROCEDURE, the Buyer hereby requests an agreement to a Variation to the Call-Off Contract dated 1 April 2023 'WP2130- SMS Provider for GOV.UK Notify'.

This change does not amount to a material change of the Framework Agreement and/or the Call-Off Contract within the meaning of the Regulations and the Law.

#### Background

- 1. On 1 April 2023 the parties entered into a Call-Off Contract (Reference WP2130) ("the Call-Off Contract) under the G-Cloud 13 Framework Agreement (RM1557.13) for a SMS Provider for GOV.UK Notify.
- 2. The estimated value of the Call-Off Contract is Up-to £38,681,500 excluding VAT.
- 3. The Call-Off Contract expires on 31 March 2024.
- 4. There is provision for a "+12 month extension option with pricing review on 02 January 2024"
- 5. The Buyer wishes to **extend** the current Call-Off Contract by **12 months**.
- 6. The Call-Off Contract Value will remain unchanged.

## The details of this "Variation" Number One are as follows:

#### 7. The expiry date shall now be 31 March 2025.

- 8. The Call-Off Contract estimated value will remain unchanged.
- 9. If the Buyer enters into a new agreement with MMGRP LIMITED before expiry of the contract term (Inc. extension) then the new agreement will take precedence and contract WP2130 will be terminated.
- 10. (a) The "Buyer" and "Supplier" mutually agree to a **maximum** chargeable rate for UK SMS/fragment delivery; **£0.0225**, effective from 01 April 2024.

(b) The maximum rate is fixed and not negotiable during the term of the contract (Inc. extension).

(c) The Supplier is required to provide full transparency of cost increases relating to their supply chain in order to obtain the agreed higher rate. This information should be submitted no later than 1 March 2024.

11. Any changes will take effect from 1 April 2024 and no sooner.
