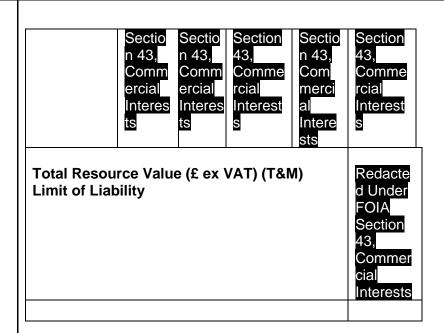

 - 2.2.1 a reference to the 'Framework Agreement' will be a reference to the 'Call-Off Contract'
 - 2.2.2 a reference to 'CCS' or to 'CCS and/or the Buyer' will be a reference to 'the Buyer'
 - a reference to the 'Parties' and a 'Party' will be a reference to the Buyer and Supplier as Parties under this Call-Off Contract
 - 2.3 The Parties acknowledge that they are required to complete the applicable Annexes contained in Schedule 7 (Processing Data) of the Framework Agreement for the purposes of this Call-Off Contract. The applicable Annexes being reproduced at Schedule 7 of this Call-Off Contract.
 - 2.4 The Framework Agreement incorporated clauses will be referred to as incorporated Framework clause 'XX', where 'XX' is the Framework Agreement clause number.
 - 2.5 When an Order Form is signed, the terms and conditions agreed in it will be incorporated into this Call-Off Contract.
- 3. Supply of services
- 3.1 The Supplier agrees to supply the G-Cloud Services and any Additional Services under the terms of the Call-Off Contract and the Supplier's Application.
- 3.2 The Supplier undertakes that each G-Cloud Service will meet the Buyer's acceptance criteria, as defined in the Order Form.
- 4. Supplier staff
- 4.1 The Supplier Staff must:
 - 4.1.1 be appropriately experienced, qualified and trained to supply the Services

- 4.1.2 apply all due skill, care and diligence in faithfully performing those duties
- 4.1.3 obey all lawful instructions and reasonable directions of the Buyer and provide the Services to the reasonable satisfaction of the Buyer
- 4.1.4 respond to any enquiries about the Services as soon as reasonably possible
- 4.1.5 complete any necessary Supplier Staff vetting as specified by the Buyer
- 4.2 The Supplier must retain overall control of the Supplier Staff so that they are not considered to be employees, workers, agents or contractors of the Buyer.
- 4.3 The Supplier may substitute any Supplier Staff as long as they have the equivalent experience and qualifications to the substituted staff member.
- 4.4 The Buyer may conduct IR35 Assessments using the ESI tool to assess whether the Supplier's engagement under the Call-Off Contract is Inside or Outside IR35.
- 4.5 The Buyer may End this Call-Off Contract for Material Breach as per clause 18.5 hereunder if the Supplier is delivering the Services Inside IR35.
- 4.6 The Buyer may need the Supplier to complete an Indicative Test using the ESI tool before the Start date or at any time during the provision of Services to provide a preliminary view of whether the Services are being delivered Inside or Outside IR35. If the Supplier has completed the Indicative Test, it must download and provide a copy of the PDF with the 14digit ESI reference number from the summary outcome screen and promptly provide a copy to the Buyer.
- 4.7 If the Indicative Test indicates the delivery of the Services could potentially be Inside IR35, the Supplier must provide the Buyer with all relevant information needed to enable the Buyer to conduct its own IR35 Assessment.
- 4.8 If it is determined by the Buyer that the Supplier is Outside IR35, the Buyer will provide the ESI reference number and a copy of the PDF to the Supplier.
- 5. Due diligence
- 5.1 Both Parties agree that when entering into a Call-Off Contract they:
 - 5.1.1 have made their own enquiries and are satisfied by the accuracy of any information supplied by the other Party
 - 5.1.2 are confident that they can fulfil their obligations according to the Call-Off Contract terms
 - 5.1.3 have raised all due diligence questions before signing the Call-Off Contract

- 5.1.4 have entered into the Call-Off Contract relying on their own due diligence
- 6. Business continuity and disaster recovery
- 6.1 The Supplier will have a clear business continuity and disaster recovery plan in their Service Descriptions.
- 6.2 The Supplier's business continuity and disaster recovery services are part of the Services and will be performed by the Supplier when required.
- 6.3 If requested by the Buyer prior to entering into this Call-Off Contract, the Supplier must ensure that its business continuity and disaster recovery plan is consistent with the Buyer's own plans.
- 7. Payment, VAT and Call-Off Contract charges
- 7.1 The Buyer must pay the Charges following clauses 7.2 to 7.11 for the Supplier's delivery of the Services.
- 7.2 The Buyer will pay the Supplier within the number of days specified in the Order Form on receipt of a valid invoice.
- 7.3 The Call-Off Contract Charges include all Charges for payment processing. All invoices submitted to the Buyer for the Services will be exclusive of any Management Charge.
- 7.4 If specified in the Order Form, the Supplier will accept payment for G-Cloud Services by the Government Procurement Card (GPC). The Supplier will be liable to pay any merchant fee levied for using the GPC and must not recover this charge from the Buyer.
- 7.5 The Supplier must ensure that each invoice contains a detailed breakdown of the G-Cloud Services supplied. The Buyer may request the Supplier provides further documentation to substantiate the invoice.
- 7.6 If the Supplier enters into a Subcontract it must ensure that a provision is included in each Subcontract which specifies that payment must be made to the Subcontractor within 30 days of receipt of a valid invoice.
- 7.7 All Charges payable by the Buyer to the Supplier will include VAT at the appropriate Rate.
- 7.8 The Supplier must add VAT to the Charges at the appropriate rate with visibility of the amount as a separate line item.
- 7.9 The Supplier will indemnify the Buyer on demand against any liability arising from the Supplier's failure to account for or to pay any VAT on payments made to the Supplier under this Call-Off Contract. The Supplier must pay all sums to the Buyer at least 5 Working Days before the date on which the tax or other liability is payable by the Buyer.
- 7.10 The Supplier must not suspend the supply of the G-Cloud Services unless the Supplier is entitled to End this Call-Off Contract under clause 18.6 for Buyer's failure to pay undisputed sums of money. Interest will be payable by the Buyer on the late payment of any

undisputed sums of money properly invoiced under the Late Payment of Commercial Debts (Interest) Act 1998.

- 7.11 If there's an invoice dispute, the Buyer must pay the undisputed portion of the amount and return the invoice within 10 Working Days of the invoice date. The Buyer will provide a covering statement with proposed amendments and the reason for any non-payment. The Supplier must notify the Buyer within 10 Working Days of receipt of the returned invoice if it accepts the amendments. If it does then the Supplier must provide a replacement valid invoice with the response.
- 7.12 Due to the nature of G-Cloud Services it isn't possible in a static Order Form to exactly define the consumption of services over the duration of the Call-Off Contract. The Supplier agrees that the Buyer's volumes indicated in the Order Form are indicative only.
- 8. Recovery of sums due and right of set-off
- 8.1 If a Supplier owes money to the Buyer, the Buyer may deduct that sum from the Call-Off Contract Charges.
- 9. Insurance
- 9.1 The Supplier will maintain the insurances required by the Buyer including those in this clause.
- 9.2 The Supplier will ensure that:
 - 9.2.1 during this Call-Off Contract, Subcontractors hold third party public and products liability insurance of the same amounts that the Supplier would be legally liable to pay as damages, including the claimant's costs and expenses, for accidental death or bodily injury and loss of or damage to Property, to a minimum of Redacted Under FOIA Section 43, Commercial Interests
 - 9.2.2 the third-party public and products liability insurance contains an 'indemnity to principals' clause for the Buyer's benefit
 - 9.2.3 all agents and professional consultants involved in the Services hold professional indemnity insurance to a minimum indemnity of Redacted Under FOIA Section 43, Commercial Interests for each individual claim during the Call-Off Contract, and for 6 years after the End or Expiry Date
 - 9.2.4 all agents and professional consultants involved in the Services hold employers liability insurance (except where exempt under Law) to a minimum indemnity of Redacted Under FOIA Section 43, Commercial Interests for each individual claim

during the Call-Off Contract, and for Redacted Under FOIA Section 43, Commercial Interests after the End or Expiry Date

- 9.3 If requested by the Buyer, the Supplier will obtain additional insurance policies, or extend existing policies bought under the Framework Agreement.
- 9.4 If requested by the Buyer, the Supplier will provide the following to show compliance with this clause:
 - 9.4.1 a broker's verification of insurance
 - 9.4.2 receipts for the insurance premium
 - 9.4.3 evidence of payment of the latest premiums due
- 9.5 Insurance will not relieve the Supplier of any liabilities under the Framework Agreement or this Call-Off Contract and the Supplier will:
 - 9.5.1 take all risk control measures using Good Industry Practice, including the investigation and reports of claims to insurers
 - 9.5.2 promptly notify the insurers in writing of any relevant material fact under any Insurances
 - 9.5.3 hold all insurance policies and require any broker arranging the insurance to hold any insurance slips and other evidence of insurance
- 9.6 The Supplier will not do or omit to do anything, which would destroy or impair the legal validity of the insurance.
- 9.7 The Supplier will notify CCS and the Buyer as soon as possible if any insurance policies have been, or are due to be, cancelled, suspended, Ended or not renewed.
- 9.8 The Supplier will be liable for the payment of any:
 - 9.8.1 premiums, which it will pay promptly
 - 9.8.2 excess or deductibles and will not be entitled to recover this from the Buyer
- 10. Confidentiality
- 10.1 The Supplier must during and after the Term keep the Buyer fully indemnified against all Losses, damages, costs or expenses and other liabilities (including legal fees) arising from any breach of the Supplier's obligations under incorporated Framework Agreement clause 34. The indemnity doesn't apply to the extent that the Supplier breach is due to a Buyer's instruction.

- 11. Intellectual Property Rights
- 11.1 Save for the licences expressly granted pursuant to Clauses 11.3 and 11.4, neither Party shall acquire any right, title or interest in or to the Intellectual Property Rights ("IPR"s) (whether pre-existing or created during the Call-Off Contract Term) of the other Party or its licensors unless stated otherwise in the Order Form.
- 11.2 Neither Party shall have any right to use any of the other Party's names, logos or trade marks on any of its products or services without the other Party's prior written consent.
- 11.3 The Buyer grants to the Supplier a royalty-free, non-exclusive, non-transferable licence during the Call-Off Contract Term to use the Buyer's or its relevant licensor's Buyer Data and related IPR solely to the extent necessary for providing the Services in accordance with this Contract, including the right to grant sub-licences to Subcontractors provided that:
 - 11.3.1 any relevant Subcontractor has entered into a confidentiality undertaking with the Supplier on substantially the same terms as set out in Framework Agreement clause 34 (Confidentiality); and
 - 11.3.2 the Supplier shall not and shall procure that any relevant Sub-Contractor shall not, without the Buyer's written consent, use the licensed materials for any other purpose or for the benefit of any person other than the Buyer.
- 11.4 The Supplier grants to the Buyer the licence taken from its Supplier Terms which licence shall, as a minimum, grant the Buyer a non-exclusive, non-transferable licence during the Call-Off Contract Term to use the Supplier's or its relevant licensor's IPR solely to the extent necessary to access and use the Services in accordance with this Call-Off Contract.
- 11.5 Subject to the limitation in Clause 24.3, the Buyer shall:
 - 11.5.1 defend the Supplier, its Affiliates and licensors from and against any third-party claim:
 - (a) alleging that any use of the Services by or on behalf of the Buyer and/or Buyer Users is in breach of applicable Law;
 - (b) alleging that the Buyer Data violates, infringes or misappropriates any rights of a third party;
 - (c) arising from the Supplier's use of the Buyer Data in accordance with this Call-Off Contract; and
 - 11.5.2 in addition to defending in accordance with Clause 11.5.1, the Buyer will pay the amount of Losses awarded in final judgment against the Supplier or the amount of any settlement agreed by the Buyer, provided that the Buyer's obligations under this Clause 11.5 shall not apply where and to the extent such Losses or third-party claim is caused by the Supplier's breach of this Contract.
- 11.6 The Supplier will, on written demand, fully indemnify the Buyer for all Losses which it may incur at any time from any claim of infringement or alleged infringement of a third party's IPRs because of the:

- 11.6.1 rights granted to the Buyer under this Call-Off Contract
- 11.6.2 Supplier's performance of the Services
- 11.6.3 use by the Buyer of the Services
- 11.7 If an IPR Claim is made, or is likely to be made, the Supplier will immediately notify the Buyer in writing and must at its own expense after written approval from the Buyer, either:
 - 11.7.1 modify the relevant part of the Services without reducing its functionality or performance
 - 11.7.2 substitute Services of equivalent functionality and performance, to avoid the infringement or the alleged infringement, as long as there is no additional cost or burden to the Buyer
 - 11.7.3 buy a licence to use and supply the Services which are the subject of the alleged infringement, on terms acceptable to the Buyer
- 11.8 Clause 11.6 will not apply if the IPR Claim is from:
 - 11.8.1 the use of data supplied by the Buyer which the Supplier isn't required to verify under this Call-Off Contract
 - 11.8.2 other material provided by the Buyer necessary for the Services
- 11.9 If the Supplier does not comply with this clause 11, the Buyer may End this Call-Off Contract for Material Breach. The Supplier will, on demand, refund the Buyer all the money paid for the affected Services.
- 12. Protection of information
- 12.1 The Supplier must:
 - 12.1.1 comply with the Buyer's written instructions and this Call-Off Contract when Processing Buyer Personal Data
 - 12.1.2 only Process the Buyer Personal Data as necessary for the provision of the G-Cloud Services or as required by Law or any Regulatory Body
 - 12.1.3 take reasonable steps to ensure that any Supplier Staff who have access to Buyer Personal Data act in compliance with Supplier's security processes
- 12.2 The Supplier must fully assist with any complaint or request for Buyer Personal Data including by:

- 12.2.1 providing the Buyer with full details of the complaint or request
- 12.2.2 complying with a data access request within the timescales in the Data Protection Legislation and following the Buyer's instructions
- 12.2.3 providing the Buyer with any Buyer Personal Data it holds about a Data Subject (within the timescales required by the Buyer)
- 12.2.4 providing the Buyer with any information requested by the Data Subject
- 12.3 The Supplier must get prior written consent from the Buyer to transfer Buyer Personal Data to any other person (including any Subcontractors) for the provision of the G-Cloud Services.
- 13. Buyer data
- 13.1 The Supplier must not remove any proprietary notices in the Buyer Data.
- 13.2 The Supplier will not store or use Buyer Data except if necessary to fulfil its obligations.
- 13.3 If Buyer Data is processed by the Supplier, the Supplier will supply the data to the Buyer as requested.
- 13.4 The Supplier must ensure that any Supplier system that holds any Buyer Data is a secure system that complies with the Supplier's and Buyer's security policies and all Buyer requirements in the Order Form.
- 13.5 The Supplier will preserve the integrity of Buyer Data processed by the Supplier and prevent its corruption and loss.
- 13.6 The Supplier will ensure that any Supplier system which holds any protectively marked Buyer Data or other government data will comply with:
 - 13.6.1 the principles in the Security Policy Framework:

13.6.4 government best practice in the design and implementation of system components, including network principles, security design principles for digital services and the secure email blueprint:

- 13.6.6 Buyer requirements in respect of AI ethical standards.
- 13.7 The Buyer will specify any security requirements for this project in the Order Form.
- 13.8 If the Supplier suspects that the Buyer Data has or may become corrupted, lost, breached or significantly degraded in any way for any reason, then the Supplier will notify the Buyer immediately and will (at its own cost if corruption, loss, breach or degradation of the Buyer Data was caused by the action or omission of the Supplier) comply with any remedial action reasonably proposed by the Buyer.
- 13.9 The Supplier agrees to use the appropriate organisational, operational and technological processes to keep the Buyer Data safe from unauthorised use or access, loss, destruction, theft or disclosure.
- 13.10 The provisions of this clause 13 will apply during the term of this Call-Off Contract and for as long as the Supplier holds the Buyer's Data.
- 14. Standards and quality
- 14.1 The Supplier will comply with any standards in this Call-Off Contract, the Order Form and the Framework Agreement.
- 14.2 The Supplier will deliver the Services in a way that enables the Buyer to comply with its obligations under the Technology Code of Practice, which is at:

- 14.3 If requested by the Buyer, the Supplier must, at its own cost, ensure that the G-Cloud Services comply with the requirements in the PSN Code of Practice.
- 14.4 If any PSN Services are Subcontracted by the Supplier, the Supplier must ensure that the services have the relevant PSN compliance certification.
- 14.5 The Supplier must immediately disconnect its G-Cloud Services from the PSN if the PSN Authority considers there is a risk to the PSN's security and the Supplier agrees that the Buyer and the PSN Authority will not be liable for any actions, damages, costs, and any other Supplier liabilities which may arise.

- 15. Open source
- 15.1 All software created for the Buyer must be suitable for publication as open source, unless otherwise agreed by the Buyer.
- 15.2 If software needs to be converted before publication as open source, the Supplier must also provide the converted format unless otherwise agreed by the Buyer.

16. Security

- 16.1 If requested to do so by the Buyer, before entering into this Call-Off Contract the Supplier will, within 15 Working Days of the date of this Call-Off Contract, develop (and obtain the Buyer's written approval of) a Security Management Plan and an Information Security Management System. After Buyer approval the Security Management Plan and Information Security Management System will apply during the Term of this Call-Off Contract. Both plans will comply with the Buyer's security policy and protect all aspects and processes associated with the delivery of the Services.
- 16.2 The Supplier will use all reasonable endeavours, software and the most up-to-date antivirus definitions available from an industry-accepted antivirus software seller to minimise the impact of Malicious Software.
- 16.3 If Malicious Software causes loss of operational efficiency or loss or corruption of Service Data, the Supplier will help the Buyer to mitigate any losses and restore the Services to operating efficiency as soon as possible.
- 16.4 Responsibility for costs will be at the:
 - 16.4.1 Supplier's expense if the Malicious Software originates from the Supplier software or the Service Data while the Service Data was under the control of the Supplier, unless the Supplier can demonstrate that it was already present, not quarantined or identified by the Buyer when provided
 - 16.4.2 Buyer's expense if the Malicious Software originates from the Buyer software or the Service Data, while the Service Data was under the Buyer's control
- 16.5 The Supplier will immediately notify the Buyer of any breach of security of Buyer's Confidential Information. Where the breach occurred because of a Supplier Default, the Supplier will recover the Buyer's Confidential Information however it may be recorded.
- 16.6 Any system development by the Supplier should also comply with the government's '10 Steps to Cyber Security' guidance:
 - https://www.ncsc.gov.uk/guidance/10-steps-cyber-security

- 16.7 If a Buyer has requested in the Order Form that the Supplier has a Cyber Essentials certificate, the Supplier must provide the Buyer with a valid Cyber Essentials certificate (or equivalent) required for the Services before the Start date.
- 17. Guarantee
- 17.1 If this Call-Off Contract is conditional on receipt of a Guarantee that is acceptable to the Buyer, the Supplier must give the Buyer on or before the Start date:
 - 17.1.1 an executed Guarantee in the form at Schedule 5
 - 17.1.2 a certified copy of the passed resolution or board minutes of the guarantor approving the execution of the Guarantee
- 18. Ending the Call-Off Contract
- 18.1 The Buyer can End this Call-Off Contract at any time by giving 30 days' written notice to the Supplier, unless a shorter period is specified in the Order Form. The Supplier's obligation to provide the Services will end on the date in the notice.
- 18.2 The Parties agree that the:
 - 18.2.1 Buyer's right to End the Call-Off Contract under clause 18.1 is reasonable considering the type of cloud Service being provided
 - 18.2.2 Call-Off Contract Charges paid during the notice period are reasonable compensation and cover all the Supplier's avoidable costs or Losses
- 18.3 Subject to clause 24 (Liability), if the Buyer Ends this Call-Off Contract under clause 18.1, it will indemnify the Supplier against any commitments, liabilities or expenditure which result in any unavoidable Loss by the Supplier, provided that the Supplier takes all reasonable steps to mitigate the Loss. If the Supplier has insurance, the Supplier will reduce its unavoidable costs by any insurance sums available. The Supplier will submit a fully itemised and costed list of the unavoidable Loss with supporting evidence.
- 18.4 The Buyer will have the right to End this Call-Off Contract at any time with immediate effect by written notice to the Supplier if either the Supplier commits:
 - 18.4.1 a Supplier Default and if the Supplier Default cannot, in the reasonable opinion of the Buyer, be remedied
 - 18.4.2 any fraud
- 18.5 A Party can End this Call-Off Contract at any time with immediate effect by written notice if:

- 18.5.1 the other Party commits a Material Breach of any term of this Call-Off Contract (other than failure to pay any amounts due) and, if that breach is remediable, fails to remedy it within 15 Working Days of being notified in writing to do so
- 18.5.2 an Insolvency Event of the other Party happens
- 18.5.3 the other Party ceases or threatens to cease to carry on the whole or any material part of its business
- 18.6 If the Buyer fails to pay the Supplier undisputed sums of money when due, the Supplier must notify the Buyer and allow the Buyer 5 Working Days to pay. If the Buyer doesn't pay within 5 Working Days, the Supplier may End this Call-Off Contract by giving the length of notice in the Order Form.
- 18.7 A Party who isn't relying on a Force Majeure event will have the right to End this Call-Off Contract if clause 23.1 applies.
- 19. Consequences of suspension, ending and expiry
- 19.1 If a Buyer has the right to End a Call-Off Contract, it may elect to suspend this Call-Off Contract or any part of it.
- 19.2 Even if a notice has been served to End this Call-Off Contract or any part of it, the Supplier must continue to provide the ordered G-Cloud Services until the dates set out in the notice.
- 19.3 The rights and obligations of the Parties will cease on the Expiry Date or End Date whichever applies) of this Call-Off Contract, except those continuing provisions described in clause 19.4.
- 19.4 Ending or expiry of this Call-Off Contract will not affect:
 - 19.4.1 any rights, remedies or obligations accrued before its Ending or expiration
 - 19.4.2 the right of either Party to recover any amount outstanding at the time of Ending or expiry
 - 19.4.3 the continuing rights, remedies or obligations of the Buyer or the Supplier under clauses
 - 7 (Payment, VAT and Call-Off Contract charges)
 - 8 (Recovery of sums due and right of set-off)
 - 9 (Insurance)
 - 10 (Confidentiality)
 - 11 (Intellectual property rights)
 - 12 (Protection of information)
 - 13 (Buyer data)
 - 19 (Consequences of suspension, ending and expiry)
 - 32 OFFICIAL-SENSITIVE COMMERCIAL

- 24 (Liability); and incorporated Framework Agreement clauses: 4.1 to 4.6, (Liability),
 24 (Conflicts of interest and ethical walls), 35 (Waiver and cumulative remedies)
- 19.4.4 any other provision of the Framework Agreement or this Call-Off Contract which expressly or by implication is in force even if it Ends or expires.
- 19.5 At the end of the Call-Off Contract Term, the Supplier must promptly:
 - 19.5.1 return all Buyer Data including all copies of Buyer software, code and any other software licensed by the Buyer to the Supplier under it
 - 19.5.2 return any materials created by the Supplier under this Call-Off Contract if the IPRs are owned by the Buyer
 - 19.5.3 stop using the Buyer Data and, at the direction of the Buyer, provide the Buyer with a complete and uncorrupted version in electronic form in the formats and on media agreed with the Buyer
 - 19.5.4 destroy all copies of the Buyer Data when they receive the Buyer's written instructions to do so or 12 calendar months after the End or Expiry Date, and provide written confirmation to the Buyer that the data has been securely destroyed, except if the retention of Buyer Data is required by Law
 - 19.5.5 work with the Buyer on any ongoing work
 - 19.5.6 return any sums prepaid for Services which have not been delivered to the Buyer, within 10 Working Days of the End or Expiry Date
 - 19.6 Each Party will return all of the other Party's Confidential Information and confirm this has been done, unless there is a legal requirement to keep it or this Call-Off Contract states otherwise.
 - 19.7 All licences, leases and authorisations granted by the Buyer to the Supplier will cease at the end of the Call-Off Contract Term without the need for the Buyer to serve notice except if this Call-Off Contract states otherwise.

20. Notices

- 20.1 Any notices sent must be in writing. For the purpose of this clause, an email is accepted as being 'in writing'.
 - · Manner of delivery: email
 - Deemed time of delivery: 9am on the first Working Day after sending

- Proof of service: Sent in an emailed letter in PDF format to the correct email address without any error message
- 20.2 This clause does not apply to any legal action or other method of dispute resolution which should be sent to the addresses in the Order Form (other than a dispute notice under this Call-Off Contract).

21. Exit plan

- 21.1 The Supplier must provide an exit plan in its Application which ensures continuity of service and the Supplier will follow it.
- 21.2 When requested, the Supplier will help the Buyer to migrate the Services to a replacement supplier in line with the exit plan. This will be at the Supplier's own expense if the Call-Off Contract Ended before the Expiry Date due to Supplier cause.
- 21.3 If the Buyer has reserved the right in the Order Form to extend the Call-Off Contract Term beyond 36 months the Supplier must provide the Buyer with an additional exit plan for approval by the Buyer at least 8 weeks before the 30 month anniversary of the Start date.
- 21.4 The Supplier must ensure that the additional exit plan clearly sets out the Supplier's methodology for achieving an orderly transition of the Services from the Supplier to the Buyer or its replacement Supplier at the expiry of the proposed extension period or if the contract Ends during that period.
- 21.5 Before submitting the additional exit plan to the Buyer for approval, the Supplier will work with the Buyer to ensure that the additional exit plan is aligned with the Buyer's own exit plan and strategy.
- 21.6 The Supplier acknowledges that the Buyer's right to take the Term beyond 36 months is subject to the Buyer's own governance process. Where the Buyer is a central government department, this includes the need to obtain approval from GDS under the Spend Controls process. The approval to extend will only be given if the Buyer can clearly demonstrate that the Supplier's additional exit plan ensures that:
 - 21.6.1 the Buyer will be able to transfer the Services to a replacement supplier before the expiry or Ending of the period on terms that are commercially reasonable and acceptable to the Buyer
 - 21.6.2 there will be no adverse impact on service continuity
 - 21.6.3 there is no vendor lock-in to the Supplier's Service at exit
 - 21.6.4 it enables the Buyer to meet its obligations under the Technology Code Of Practice

- 21.7 If approval is obtained by the Buyer to extend the Term, then the Supplier will comply with its obligations in the additional exit plan.
- 21.8 The additional exit plan must set out full details of timescales, activities and roles and responsibilities of the Parties for:
 - 21.8.1 the transfer to the Buyer of any technical information, instructions, manuals and code reasonably required by the Buyer to enable a smooth migration from the Supplier
 - 21.8.2 the strategy for exportation and migration of Buyer Data from the Supplier system to the Buyer or a replacement supplier, including conversion to open standards or other standards required by the Buyer
 - 21.8.3 the transfer of Project Specific IPR items and other Buyer customisations, configurations and databases to the Buyer or a replacement supplier
 - 21.8.4 the testing and assurance strategy for exported Buyer Data
 - 21.8.5 if relevant, TUPE-related activity to comply with the TUPE regulations
 - 21.8.6 any other activities and information which is reasonably required to ensure continuity of Service during the exit period and an orderly transition
- 22. Handover to replacement supplier
- 22.1 At least 10 Working Days before the Expiry Date or End Date, the Supplier must provide any:
 - 22.1.1 data (including Buyer Data), Buyer Personal Data and Buyer Confidential Information in the Supplier's possession, power or control
 - 22.1.2 other information reasonably requested by the Buyer
- 22.2 On reasonable notice at any point during the Term, the Supplier will provide any information and data about the G-Cloud Services reasonably requested by the Buyer (including information on volumes, usage, technical aspects, service performance and staffing). This will help the Buyer understand how the Services have been provided and to run a fair competition for a new supplier.
- 22.3 This information must be accurate and complete in all material respects and the level of detail must be sufficient to reasonably enable a third party to prepare an informed offer for replacement services and not be unfairly disadvantaged compared to the Supplier in the buying process.

- 23. Force majeure
- 23.1 If a Force Majeure event prevents a Party from performing its obligations under this Call-Off Contract for more than 30 consecutive days, the other Party may End this Call-Off Contract with immediate effect by written notice.

24. Liability

- 24.1 Subject to incorporated Framework Agreement clauses 4.1 to 4.6, each Party's Yearly total liability for Defaults under or in connection with this Call-Off Contract shall not exceed the greater of Redacted Under FOIA Section 43, Commercial Interests of the Charges paid and/or committed to be paid in that Year (or such greater sum (if any) as may be specified in the Order Form).
- 24.2 Notwithstanding Clause 24.1 but subject to Framework Agreement clauses 4.1 to 4.6, the Supplier's liability:
 - 24.2.1 pursuant to the indemnities in Clauses 7, 10, 11 and 29 shall be unlimited; and
 - 24.2.2 in respect of Losses arising from breach of the Data Protection Legislation shall be as set out in Framework Agreement clause 28.
- 24.3 Notwithstanding Clause 24.1 but subject to Framework Agreement clauses 4.1 to 4.6, the Buyer's liability pursuant to Clause 11.5.2 shall in no event exceed in aggregate Redacted Under FOIA Section 43, Commercial Interests.
- 24.4 When calculating the Supplier's liability under Clause 24.1 any items specified in Clause 24.2 will not be taken into consideration.

25. Premises

- 25.1 If either Party uses the other Party's premises, that Party is liable for all loss or damage it causes to the premises. It is responsible for repairing any damage to the premises or any objects on the premises, other than fair wear and tear.
- 25.2 The Supplier will use the Buyer's premises solely for the performance of its obligations under this Call-Off Contract.
- 25.3 The Supplier will vacate the Buyer's premises when the Call-Off Contract Ends or expires.
- 25.4 This clause does not create a tenancy or exclusive right of occupation.
- 25.5 While on the Buyer's premises, the Supplier will:

- 25.5.1 comply with any security requirements at the premises and not do anything to weaken the security of the premises
- 25.5.2 comply with Buyer requirements for the conduct of personnel
- 25.5.3 comply with any health and safety measures implemented by the Buyer
- 25.5.4 immediately notify the Buyer of any incident on the premises that causes any damage to Property which could cause personal injury
- 25.6 The Supplier will ensure that its health and safety policy statement (as required by the Health and Safety at Work etc Act 1974) is made available to the Buyer on request.
- 26. Equipment
- 26.1 The Supplier is responsible for providing any Equipment which the Supplier requires to provide the Services.
- 26.2 Any Equipment brought onto the premises will be at the Supplier's own risk and the Buyer will have no liability for any loss of, or damage to, any Equipment.
- 26.3 When the Call-Off Contract Ends or expires, the Supplier will remove the Equipment and any other materials leaving the premises in a safe and clean condition.
- 27. The Contracts (Rights of Third Parties) Act 1999
- 27.1 Except as specified in clause 29.8, a person who isn't Party to this Call-Off Contract has no right under the Contracts (Rights of Third Parties) Act 1999 to enforce any of its terms. This does not affect any right or remedy of any person which exists or is available otherwise.
- 28. Environmental requirements
- 28.1 The Buyer will provide a copy of its environmental policy to the Supplier on request, which the Supplier will comply with.
- 28.2 The Supplier must provide reasonable support to enable Buyers to work in an environmentally friendly way, for example by helping them recycle or lower their carbon footprint.
- 29. The Employment Regulations (TUPE)
- 29.1 The Supplier agrees that if the Employment Regulations apply to this Call-Off Contract on the Start date then it must comply with its obligations under the Employment Regulations

and (if applicable) New Fair Deal (including entering into an Admission Agreement) and will indemnify the Buyer or any Former Supplier for any loss arising from any failure to comply.

29.2 Twelve months before this Call-Off Contract expires, or after the Buyer has given notice to End it, and within 28 days of the Buyer's request, the Supplier will fully and accurately disclose to the Buyer all staff information including, but not limited to, the total number of staff assigned for the purposes of TUPE to the Services. For each person identified the Supplier must provide details of:

29.2.1	the activities they perform
29.2.2	age
29.2.3	start date
29.2.4	place of work
29.2.5	notice period
29.2.6	redundancy payment entitlement
29.2.7	salary, benefits and pension entitlements
29.2.8	employment status
29.2.9	identity of employer
29.2.10	working arrangements
29.2.11	outstanding liabilities
29.2.12	sickness absence
29.2.13	copies of all relevant employment contracts and related documents
29.2.14	all information required under regulation 11 of TUPE or as reasonably
	requested by the Buyer

The Supplier warrants the accuracy of the information provided under this TUPE clause and will notify the Buyer of any changes to the amended information as soon as reasonably possible. The Supplier will permit the Buyer to use and disclose the information to any prospective Replacement Supplier.

- 29.3 In the 12 months before the expiry of this Call-Off Contract, the Supplier will not change the identity and number of staff assigned to the Services (unless reasonably requested by the Buyer) or their terms and conditions, other than in the ordinary course of business.
- 29.4 The Supplier will co-operate with the re-tendering of this Call-Off Contract by allowing the Replacement Supplier to communicate with and meet the affected employees or their representatives.
- 29.5 The Supplier will indemnify the Buyer or any Replacement Supplier for all Loss arising from both:
 - 29.5.1 its failure to comply with the provisions of this clause

- 29.5.2 any claim by any employee or person claiming to be an employee (or their employee representative) of the Supplier which arises or is alleged to arise from any act or omission by the Supplier on or before the date of the Relevant Transfer
- 29.6 The provisions of this clause apply during the Term of this Call-Off Contract and indefinitely after it Ends or expires.
- 29.7 For these TUPE clauses, the relevant third party will be able to enforce its rights under this clause but their consent will not be required to vary these clauses as the Buyer and Supplier may agree.

Additional G-Cloud services

- 30.1 The Buyer may require the Supplier to provide Additional Services. The Buyer doesn't have to buy any Additional Services from the Supplier and can buy services that are the same as or similar to the Additional Services from any third party.
- 30.2 If reasonably requested to do so by the Buyer in the Order Form, the Supplier must provide and monitor performance of the Additional Services using an Implementation Plan.

31. Collaboration

- 31.1 If the Buyer has specified in the Order Form that it requires the Supplier to enter into a Collaboration Agreement, the Supplier must give the Buyer an executed Collaboration Agreement before the Start date.
- 31.2 In addition to any obligations under the Collaboration Agreement, the Supplier must:
 - 31.2.1 work proactively and in good faith with each of the Buyer's contractors
 - 31.2.2 co-operate and share information with the Buyer's contractors to enable the efficient operation of the Buyer's ICT services and G-Cloud Services

32. Variation process

- 32.1 The Buyer can request in writing a change to this Call-Off Contract if it isn't a material change to the Framework Agreement/or this Call-Off Contract. Once implemented, it is called a Variation.
- 32.2 The Supplier must notify the Buyer immediately in writing of any proposed changes to their G-Cloud Services or their delivery by submitting a Variation request. This includes any changes in the Supplier's supply chain.

- 32.3 If Either Party can't agree to or provide the Variation, the Buyer may agree to continue performing its obligations under this Call-Off Contract without the Variation, or End this CallOff Contract by giving 30 days notice to the Supplier.
- 33. Data Protection Legislation (GDPR)
- 33.1 Pursuant to clause 2.1 and for the avoidance of doubt, clause 28 of the Framework Agreement is incorporated into this Call-Off Contract. For reference, the appropriate UK GDPR templates which are required to be completed in accordance with clause 28 are reproduced in this Call-Off Contract document at Schedule 7.

Schedule 1: Services

From the Start Date of the Contract, the Supplier will be required to provide resource (in accordance with the SFIA rate card in the Supplier's Contract Award Service 'Pricing Document') for the development of a DMS-DMA CPD & External Training Management application.

The scope of all work for the DMA CPD & External Training application is detailed in Statement of Work 'Defence Digital Foundry: DMA CPD & External Training App SoW', as approved in writing, under Annex A to Schedule 1: Statement of Work.

These will be in addition and agreed during the Call-Off Contract Period, when the Buyer and Supplier agree and execute additional Statement of Works. Agreed and approved in writing. Upon execution of a Statement of Work, the provisions detailed therein shall be incorporated into the Call-Off Contract under Schedule 1 Services, subject to a Contract Amendment.

Work will be delivered through a combination of a Live Service Support monthly SLA support agreement and Service Management & Continuous Service Iteration (CSI) for small application enhancements.

- Live Service Support Monthly SLA A monthly fixed fee, to be agreed, would provide access to a service desk and ticketing system and resolution of P1 and P2 issues through our managed services team, in addition to basic maintenance and security patching. Full details of coverage will be provided in the Statement of Work.
- 2. Service Management & Continuous Service Iteration (CSI) The remaining budget would be utilised for Service Management and Continuous Service Iteration (CSI) at the request of the Product Owner. Requests would be reported and recorded in Jira, estimated by the team for approval and then scheduled as required for delivery. We would retain a shared budget reconciliation and burndown for transparency on spend and agree deliverables up front before work is committed.

Phase 2 of the Cons Turbulence (nee Placements Tracking) Monitoring App: Charges total a maximum of Redacted Under FOIA Section 43, Commercial Interests Limit of Liability. This will be addition to the above and agreed in separate Statement of Work agreements. Upon execution of a Statement of Work, the provisions detailed therein shall be incorporated into the Call-Off Contract under Schedule 1 Services, subject to a Contract Amendment.

Work will be delivered through agile development and charged on a Time and Materials based, and budget drawn down against for further application development.

Scope of development backlog to include, but not limited to:

- UMBRACO CMS migration
- Migration of historic data A user friendly look back capability. Secure and robust (periodic backup of the data). Standardised improving quality and resulting in workforce/ time efficiency.
- End to end digitised Job Plan Standardised, secure, workforce/ time efficiency.
- Pipelining of data from analytics platform e.g., DMS IX, MARCONI etc. Provides larger dataset to exploit and reveal patterns and trends improving the ability to exploit key data accurately and easily resulting in more precise NVSP prediction and ABC forecasting. This is also crucial in the duty of care/ welfare to our personnel where the business area will be able to identify overperformance increasing risk of burnout and mitigate that risk.
- Onboarding of additional cadres onto the application Recent assurance deep dives have exposed concerns of not being able to accurately track whether personnel are meeting CCE. Onboarding other cadres will resolve this.
- Qualitative PAs (Ability to delve to a more granular level than DCC) Far greater assurance of CCE and time spent on certain activities.
- Notification, comms messages Improves the communication stream to all stakeholders/ users.

Additional requirements identified during feedback from phase 1 – As this is an iterative application constant feedback from the previous phase will increase functionality and further improve the application.

Problem

1. There is a requirement for a Continuous Professional Development (CPD) external training application to support the process for Defence Medical Services (DMS) healthcare professionals (HCPs) applying for CPD, external education courses and training. The current system involves labour intensive manual input including multiple approvers uploading data on to application forms, conversion to spreadsheets and manual upload onto TAFMIS. The current system is unfit for purpose with no ability for case management, and cannot give real time analysis of training data, accurate spend or predict future requirements which currently sits as a risk at 2* level. An enduring issue with training applications has been reticence in submission, which in part has been due to a complicated application system. An integrated app with user friendly features that can be accessed and viewed using any device would also resolve the continual frustrations experienced by users with the current system.

Strategic Case

2. DMS lacks an accurate, time-efficient, and reliable process for external education and training applications, and training requirement analysis. The current system is labour intensive, susceptible to manual errors, cannot intelligently analyse training requirement data and is unsustainable with the current workforce. Accurate estimation of training requirements is an enduring problem across all three single Services and Defence Primary Healthcare (DPHC). The current system does not utilise real time data, cannot accurately predict training requirements and therefore overestimates training need in some areas, whilst underestimating the wider training need for the Clinical Employment Groups and their changing ways of future employment. This requirement has been hastened by the new CPD funding and consequent increase in applications, however the second order effect of this digitised solution would be for use on all external training and education applications which use the same system, and would therefore provide accurate, intelligent and real time data on current training applications as well as future forecasting and predictive spend.

Purpose & Scope

- 3. This document lays out a Statement of Work (SoW) for the Supplier to provide resource using Government Digital Standards (GDS) principles to support discovery through to Public BETA delivery a Minimal Viable Product (MVP) at the end of Phase 1 to support an accurate, time-efficient and reliable process for CPD, external education and training applications, and training requirement analysis for Defence Medical Services (DMS) personnel, and specifically enable the outcomes detailed within this document.
- 4. It outlines the mechanisms for contract management, the expected outcomes, and potential tasks to be supported with the contracted resource. It will be initially presented in draft form to be discussed and agreed with supplier and then reviewed monthly as part of the contract management process. The document will provide a flexible manner to agree work and track deliverables.
- 5. The solution is to take the form of an integrated IT system including a user interface to input the required data as well as a database to case manage and store. The tool will also provide high fidelity data for the Defence Medical Academy and wider Training Requirements Authorities to undertake accurate training requirement analysis, the ability for Defence Consultant Advisors (DCAs) and Heads of Cadres to rapidly understand the up-to-date clinical SQEP of cadre members and track clinical progression along training pathways. Accurate training requirement analysis will ensure the right training is funded and utilised, providing the correct SQEP to the Front Line Commands for deployment.

- 6. The overall outcome is to support the user through the delivery of a user interface application and database that can input/ interpret the data, and populate a data base, and also allow its exploitation through an open API for consumption via MARCONI (Palantir Foundry software) or DMSIX platform in the future. This will reduce user input, allow the DMA External Education and Training Support service (EETS) to rapidly and accurately manage CPD and training applications, analyse training requirement data and improve predicted annual funding requirements for CPD and external training.
- 7. The secondary output of this product is to create a supporting database which is structured and compiled on appropriate technical architecture, within MOD environments that enables data analysis and exploitation via either PowerBi via MODNet, Palantir Foundry software or the DMSIX platform in the future. Any data storage should be built directly into the DMSIX platform for the maximum data value and long-term endurance, technical complexities of this must be understood as an outcome of the Discovery phase.
- 8. Benefits in replicating delivery best practices, operating efficiencies, and re-use of code and components from the MyNavy and the JHG Consultant Monitoring Application products should be capitalised upon to provide value in line with the Digital Backbone and Foundry strategies.
- 9. The front-end user interface will use existing MyNavy UX/UI and branding, with incorporation of Umbraco as the CMS if appropriate.

Outcomes

- 10. Outputs required include but are not limited to:
 - a. Front End UI. Deliver a defence gateway accessed user interface app that is accessible via a service persons personal device.
 - b. Case Management and Processing UI. Deliver a case management interface for administrative staff to manage CPD, external training applications and other required data.
 - c. Umbraco (CMS). Utilisation of Umbraco as the Content Management System with creation of customer content management to provide a sustainable way for DMS administrators to update and enhance the page, section, feature, or global navigation as required.
 - d. Customer/User Group Mapping. Take the initial workshop data and continue to map out and engage with existing customers/user groups for potential touch point systems and operations.
 - e. Define future operating model with R&R's. A suitable operating model which provides architectural ownership and control by DDF, but also collaborative or separate sS product development by other software house offerings.
 - f. Database. Establish a structured and standardised database (architecture TBC on discovery) that is compiled from data entered into the PWA front end interface.
 - g. Data storage. Understand the technical complexities involved in building data storage directly into the DMSIX platform.
 - h. API. Completion of an open API that can be digested by either MODNet PowerBi or Palantir Foundry software.

- i. Business case support and stakeholder engagement/presentations. Media and comms support, including graphics creation and strategic content creation. Support for future operating model to deliver further phases, sustain and iterate on original Phase 1 MVP. The Discovery phase must include how the platform is to scale and iterate against Continuous Service Improvement (CSI) as an outcome.
- 11. This will be managed by way of a Statement of Work, reviewed monthly by the Authority to allow reprioritisation as required within the Programme.
- 12. Critical Success Factor (CSF). The CPD and External Training Application should be a coherent part of the employee offering to DMS personnel. In allowing users to apply for CPD and all external training courses, the following success factors should be realised:
 - a. Employee Empowerment this includes supporting individuals to take responsibility for their own training pathways, careers, and professional lives, enabling easy access to apply for required training, visibility of the full training application process and through automation, support optimisation of routine administration processes.
 - b. Personalisation delivering access to the tools which best relate to the individual and their needs, tailored to DMS personnel and delivering against their specific needs. A custom user experience to emphasise that Defence cares for its people.

Out of scope

- 13. Due to budgetary and timeline constraints, there will be no service assessment between phases unless carried out by DDF under separate funding. The DDF product manager Redacted Under FOIA Section 40, Personal Information in partnership with the DMS-DMA product lead Redacted Under FOIA Section 40, Personal Information will be responsible for approval of outcomes associated to each phase and its deliverables.
- 14. Requirements will be identified during the discovery phase. Requirements will be estimated and prioritised with the DDF product manager Redacted Under FOIA Section 40, Personal Information in partnership with the DMS-DMA product lead Redacted Under FOIA Section 40, Personal Information to define the scope of the MVP within the available budget and timeline.
- 15. All hosting, infrastructure and licencing costs will be covered by DDF outside of the funding covered in this Statement of Work.

Project governance

- 16. This project will be governed by standards and escalation measures agreed during the initial phase, utilising the current systems within DDF that enable effective digital product and service delivery.
- 17. **Tooling**. DDF's SaaS incidence of the Atlassian suite is to be used to record all completed work. JIRA must be used to track cadence, burnrate, backlog and milestones of the project through its lifecycle, with appropriate reporting up to D2S as required.

Project roles

18. The roles displayed in the breakdown of charges (Schedule 2: Call-Off Contract charges) have been identified as having the specialist skill set required to deliver the demanding needs of this project.

19. This is estimated and is liable to change throughout the duration of the project as requirements become clear. Changes in roles required will be agreed between the Great State Delivery Lead and DDF Product Manager and will be subject to a formal Contract Amendment. All figures in the table below are calculated excluding VAT.

Project milestones

- 20. Throughout the product delivery phases, DMS CDIO's team will also be involved with all decision points and milestones, including how the application suite's service management post release will be adopted.
- 21. The following project milestones have been suggested, though dates may need to be re-evaluated throughout the project, depending on unknown issues and team availability, and are based on an assumed start date of Monday 20th November 2023:
 - a. 20th November 2023 Initial meeting with customer to identify key contacts/project stake-holders and initiate introductions.
 - b. 20th November 2023 Initial kick off meeting with project stakeholders
 - c. 8th December 2023 Completion of audience workshops technical and user based
 - d. 21st December 2023 Completion of discovery phase and associated outputs
 - e. 5th January 2023 Start of prototyping and solution design phase
 - f. 12th January 2023 Completion of wireframes and prototype for testing
 - g. 17th January 2023 Completion of user testing and applied changes
 - h. 18th January 2023 User interface design, write up of user requirements and completion of technical design
 - i. 19th January 2023 Completion of prototyping and solution design phase and agreed outputs
 - j. 22nd January 2023 Start implementation and build phase
 - k. 31st March 2023 Completion of MVP of the application with approval to release

Finance Reporting

22. Great State will send invoices directly to the DMS at the end of each calendar month on a Time and Materials reconciliation, in accordance with the 'Call-Off Contract charges and payment' section of Part A: Order Form, and approved by Redacted Under FOIA Section 40, Personal Information, on behalf of the DMS Product Owner Redacted Under FOIA Section 40, Personal Information.

Cyber Security

- 23. The Authority has a duty to protect itself from Cyber threats and we extend this to Suppliers we engage with. As an extension of the Government's Cyber Essentials Scheme, the Authority, working together with Industry and other Government Departments, have developed a more robust Cyber Security Model, under the umbrella of the Defence Cyber Protection Partnership (DCPP). All prime contractors must have the cyber security controls specified in DEF Stan 05-138 (Cyber Security for Defence Suppliers), as appropriate to the cyber risk level specified in the contract.
- 24. A Cyber Risk Assessment has been conducted by Defence Digital Foundry as part of the commercial process and due to the nature of the data at OSP, the level of risk has been assessed as Redacted Under FOIA Section 43, Commercial Interests. To ensure that potential suppliers at all levels of the supply chain can demonstrate compliance with the Cyber Risk Profile of Redacted Under FOIA Section 43, Commercial Interests, a Supplier Assurance Questionnaire (SAQ) is required to be completed before contract award.

Assumptions

- 25. DMS-DMA will be responsible for securing the availability of users to support discovery activity. Project timelines and milestones will be impacted if this cannot be achieved by dates set out in the section above.
- 26. DMS-DMA will provide a Product Owner (minimum 40% daily capacity) as a single point of contact, who will be responsible for briefing Great State on requirements and managing and consolidating all internal feedback from relevant stakeholders.
- 27. As we are working using an agile methodology, scope is flexible. Requirements will be prioritised with the DDF product manager Redacted Under FOIA Section 40, Personal Information in partnership with the DMS-DMA product lead Redacted Under FOIA Section 40, Personal Information Should additional requirements be raised, these will be assessed within the team and a decision made about removing another feature/requirement or allocating more budget to increase the duration or the extent of the team to accommodate the requirement, within the permissible limits of The Public Contracts Regulations 2015.
- 28. DDF will arrange for formal agreement with Navy Digital for the reuse of MyNavy design system, codebase, component library and technical services i.e., Identity. If this is not possible, the scope of requirements to be delivered will be greatly reduced for the available budget.
- 29. Content requirements including both content creation and content entry will be fulfilled by DMS-DMA, or at the request of the Product Owner.
- 30. Governance and project processes will be defined and agreed upfront and should be followed by all parties. Appropriate tooling will be agreed between Great State and DDF.
- 31. DDF in partnership with the DMS will be responsible for outputs being compliant with relevant MOD regulations. All content/copy requiring legal approval should be obtained by DDF.
- 32. All required people data will be available from the army data warehouse via existing APIs.
- 33. Any licensing or third-party costs required to deliver the digital service will be paid for by DDF outside of this scope of work and funding.
- 34. Great State will not deliver iOS and android applications for this scope of work due to constraints on timeline and budget.
- 35. DDF Development Services will lead and manage on all security and accreditation processes.
- 36. DDF Development Services will advise on the most suitable options for hosting of all required environments and supporting infrastructure services.

Input materials

37. Input materials which DDF must provide to Great State to enable us to conduct the activities listed above may be required throughout the project. Where the input materials are to be provided by a third party on behalf of DDF, it is DDF's responsibility to ensure timely and complete delivery to Great State.

38. In the event Great State is unable to provide the services due to DDF's failure to provide the input material, Great State shall be entitled to the remedies in either the Master Services Agreement or Terms and Conditions, that this SoW is governed by.

Expenses and third-party costs

39. Third-party costs may arise during the course of the project. If these arise, Great State will make these known to the DDF, including the amount. The expenditure of these costs will be agreed in writing and in advance by both parties and will be drawn from the agreed funding.

Risks

40. Project risks will be agreed and managed through agreed governance procedures set out during the kick off and discovery phase. They will be reviewed on an ongoing basis, and where required, escalated to senior stakeholders for resolution.

Roles and responsibilities

41. A Delivery Manager will be allocated to the project on approval of the SoW and will be your primary contact for all requests and will manage the requests in the team. Other client services team members may be called in to assist at certain periods to ensure cover.

- 1.1 The Contractor shall provide a Knowledge Transfer report (be that written or oral) to the Authority, at the end of each 'Period of Performance' (on a monthly occurrence), the knowledge transfer activity that has been conducted under this contract. B - Key Performance Indicators (KPIs)

Clause 2 – KPIs

- 2.1 The Contractor's performance under the contract shall be measured by the Authority's Senior Responsible Owner (SRO), or a named Crown Servant who has formal delegation from the SRO, at each 'Period of Performance' (on a monthly occurrence) against the Key Performance Indicators (KPIs) detailed in the Call-Off Contract, Table A (Performance Measurements). A joint meeting between the Buyer and the Supplier will take place on a monthly basis to review and assess performance against each KPI. The outcome of those meetings will be documented by email.
- 2.2 In accordance with DEFCON 642 (07/21) Progress Meetings, the Authority reserves the right to invoke Progress Meetings (hereinafter referred to as "Performance Review Meetings") for each 'Period of Performance' to review the measurement of achievement for the Period of Performance against the metrics and scores set out in Call-Off Contract, Table A (Performance Measurements) of the Contract.

- 2.3 Should they be invoked, Performance Review Meetings will be held at a location and time to be agreed between the Contractor and the Senior Responsible Owner (SRO) and agreed at least **five (5) working days** before the Performance Review Meeting is scheduled.
- 2.4 During a Period of Performance, the Contractor must score 3 or more against each individual KPI for the Contractor's performance to be deemed "acceptable" by the Authority. If during the Period of Performance, the Contractor's score against any individual KPI is less than 3, the Contractor's performance shall be deemed by the Authority's Project Manager as being "below expectations" and in the first instance the Authority and Contractor shall have a contractual obligation to collaboratively create an 'Improvement Plan', which will become a contractual obligation to adhere to, for the remainder of the Call-Off Contract.
- 2.5 During a Period of Performance, where delivery fails to achieve acceptable quality, as detailed in Clause 2.4, on a frequent basis (to be determined by the Authority) despite Improvement Plans, the Authority reserves the right to End this Call-Off Contract at any time, without cause, by giving 30 days' written notice to the Supplier (as per Clause 18.1 in Part B: Terms and conditions).
- 2.6 For the purpose of Clause 2.4, an 'Improvement Plan' shall be defined as "a formal written document capturing the processes and procedures which the Contractor shall put in place to improve the service provided in the Contract". The plan should include, but is not limited to, an on-going review of the services and actions that the Contractor shall take to improve these, a clear objective list of service failures, a clear objective measurable list of improvement expected, clear timescales for improvement and a clear list of training requirements; etc.
- 2.7 The 'Improvement Plan' shall be approved and monitored by an authorised member of both parties.
