Conditions of Tender for Grass Cutting

1. The tender shall be made on this form provided by WPC without alteration and with a copy of the insurance certificate and method statement. The Service Level Agreement, which contains Conditions of the Agreement and Service Specification has been read and accepted.
2. The prices inserted into the schedule of rates shall cover all appropriate costs which are to be borne by the contractor as part of the contract. Tenderers shall satisfy themselves that the schedule is correct and shall submit rates in respect of all the work specified.
3. Tenderers shall submit with their tenders a certificate completed by the insurance company or their broker confirming **minimum** insurance cover of £10 million in respect of any one accident. There shall be a Principal's Clause indemnifying WPC.
4. No allowance for Value Added Tax shall be included in the tender.
5. The tender may be returned as follows:
 - Via email to Tender@Wootton-PC.gov.uk and received by the Clerk to the Council/Responsible Financial Officer, by **12 noon on Wednesday 25th February 2026**.
 - Via a sealed envelope marked GRASS CUTTING TENDER and received by the Clerk to the Council/Responsible Financial Officer, by **12 noon on Wednesday 25th February 2026** at the address shown at the top of page 1. It is recommended that tenderers courier their tender for delivery to WPC.
 - The envelope must not bear any indication of the amount tender price.
 - The name and address of the tenderer shall be written on the back of the envelope.
 - Late tenders will either not be acknowledged if received via email or will be returned to the tenderer unopened.
6. Tenderers must not communicate with WPC nor any individual councillor after the tender submission date. Any attempt by a tenderer to influence the result of the tender will lead to their disqualification.
7. In the interests of openness and transparency, tenderers must disclose any works (previously, currently or proposed) undertaken for any member of WPC.
8. WPC intends to announce the result of the tender on **Thursday 12th March 2026**.
