The opportunity

This funding programme is a response to research published by GambleAware in 2023, demonstrating that people from particular groups in society face additional burdens of gambling harm, as well as barriers in accessing services which meet their needs. This fund aims to drive change within the sector by investing in activities which respond to the research recommendations. The overall ambition is to reduce the inequalities which exist relating to gambling harm for women and people from minority religious and ethnic minority communities.

This project is funded by the Regulatory Settlement allocated to GambleAware by The Gambling Commission in accordance with their Statement of Principles for determining financial penalties. In keeping with the principles, funding from regulatory settlements to GambleAware will be used for specific, agreed purposes that accelerate our commissioning plans, including encouraging innovative practices.

This is an opportunity for innovative thinking within gambling-harms prevention and support, and we are encouraging collaboration between gambling harm specialist providers and other third sector organisations. We particularly welcome applications from smaller and/ or lived experience led organisations through this funding programme.

The research focusing on the impact of gambling harm among women and among minority communities demonstrates the individual experiences, structural inequalities and stigma for these communities in relation to gambling and gambling harms. Whilst drivers behind gambling participation and associated risk factors vary, both women and minority communities experience significant gaps in service provision.

For women, there is a lack of a gender-sensitive approaches to treatment and support, and women as affected others often are not aware of the support available or are as well-served in terms of some of their experiences of trauma². Some of the other reasons surrounding low take up of support among women include practical barriers, such as distance to and the location of support, financial constraints, additional burdens of stigma, and experience of domestic abuse which can make accessing support even harder³.

For minority communities, a general distrust towards organisations that are not embedded within those communities may be a contributing factor to low awareness and use of gambling specific treatment and support⁴. In addition, stigma may also lead individuals to feel that they cannot access informal support, with minority groups statistically significantly less likely to talk to friends and family if they were worried about their gambling (56% vs. 63% of the white British majority group)⁵.

For this programme, we are using the definition of minority groups used in the Ipsos research as follows:

"Referring to the primary audience for this study, minority groups, though are hugely heterogeneous and diverse communities, are subject to similar contexts in terms of living in an inequitable, post-colonial Great Britain marked by structural racism and discrimination. For the purposes of this research, these groups include those who meet at least one of the following criteria (as per categories used by ONS data⁶):

- Identify as a member of an ethnic minority group;
- Identify as a member of a religious minority group (not Christian);
- Those who do not speak English as their first language".


2. Building Knowledge of Women's Lived Experience of Gambling and Gambling Harms Across Great Britain, undertaken by IFF, commissioned by GambleAware:

Outcomes

The overall aim of this funding is to reduce the inequalities experienced relating to gambling harms for women and people from minority communities.

As part of the programme design, we have co-produced a theory of change diagram which attempts to articulate the overall impact we are seeking to achieve as well as the short, medium and long term outcomes (or changes) required to achieve this. As with any theory of change, this is intended to be a living document, and it will be reviewed alongside the portfolio of organisations funded within this programme.



We are expecting applicants to respond to one or more areas within the theory of change diagram, explaining how you will address one or more of the outcomes listed within the document.

As part of the development of this programme, we collaborated both with the researchers involved in the research publications listed above, and with people with lived experience of gambling harms. This is an overview of the co-produced key principles underpinning our approach to this funding programme:

• Projects where there is a clear reason why women or minority communities would engage / where these groups have power in the definition and establishing of the service.

- Targeted at areas of highest need (this might be depth of need rather than prevalence).
- Commitment to building capability and capacity around gambling harms. Non-gambling harm specialist organisations may need to partner with a specialist organisations to ensure we build on the skills and knowledge of the current system.
- Provide greater choice and options for women and people from minority communities to engage in support and treatment.
- Commitment to sharing learning and good practice.
- Having the infrastructure and systems that work for people from minority communities and women. Mobilising movement building is important. Projects funded do not have to be beneficiary/client facing interventions.
- Focus on preventing duplication and seeking innovation.

The list below is intended to provide some examples of the types of projects we might receive. They are not prescriptive or definitive:

- Tailored support for women or people from minority communities.
- Investing in women and minority community-led organisations trusted organisations.
- Interventions to reduce barriers to access support.
- Projects which focus on reducing stigma and shame, enabling people to recognise their gambling harm and take steps to seek treatment or support.
- Sensitised gender or cultural competency workforce training.
- Network building mobilising communities who can campaign and influence change.
- Strengthening and sharing good practice within the current system to improve access and outcomes.

Decision making

In line with our overall approach to commissioning, applications will be reviewed by a member of the GambleAware team to consider the following elements:

- a. Evidence of need
- b. Delivery model and approach
- c. Potential outcomes and impact
- d. Value for money and sustainability
- e. Organisation's track record

A funding panel, which will include Lived Experience, will meet to discuss each application and make recommendations on which projects should be funded.

Criteria

The following are the key criteria for this fund. In the application form linked below, you will be asked to tick to confirm your eligibility:

1	The impact of the activity and any direct delivery of services is in England, Scotland and/or Wales.
2	We are predominantly seeking to fund registered charities, or not for profit organisations. We will also fund other types of organisations, but your governing documents must clearly outline the organisation's social purpose, demonstrate that profits are used for this purpose and that an asset lock is in place.
3	You have not requested more than 50% of your previous year's turnover. This is to ensure we are funding organisations with a track record and financial management experience. If you do not meet the 50% threshold, please provide some more details in section 6.3 of the application form.
4	The funding will not be used on any projects that are co-funded by the gambling industry.
5	Activities must be in line with GambleAware's <u>charitable objectives</u> .

Monitoring, evaluation, and learning

GambleAware is committed to proportionate monitoring and evaluation across all our funded projects and programmes in order to generate learning to inform future services and contribute to the body of evidence to influence wider policy and practice.

Once funding has been allocated, we will work with successful applicants to agree project-specific outcomes and implement monitoring procedures. Successful applicants must be willing to be actively engaged and involved with an external evaluation of the portfolio which will be commissioned by GambleAware.

Partnerships

We are looking to fund a range of organisations including current <u>National Gambling Support</u> <u>Network</u> providers, other current funded partners and organisations new to GambleAware.

We are encouraging partnership applications. Where an organisation doesn't have experience within gambling harms, we would suggest reaching out to one of the NGSN partners, or alternatively please contact the GambleAware team for support: commissioning@gambleaware.org

Additionally, gambling harm specialist organisations may benefit from partnering with organisations that have specific reach to women or minority ethnic or minority religious communities.

Funding levels

The are two levels of funding available:

• Level 1: £150,000 for up to two years for smaller/ emergent organisations with less of a track record within the gambling harms sector.

• Level 2: £300,000 for up to two years for larger organisations or more established projects.
