CONTRACT EXTENSION AGREEMENT

Atamis Business Case Reference: BC-25184

THIS EXTENSION AGREEMENT is made on 01 April 2025

BETWEEN:

- (1) **NHS England** of Wellington House, 133 – 155 Waterloo Road, London SE1 8UG (“**the Authority**”); and
- (2) **Liverpool University Hospitals NHS Foundation Trust** of Prescot Street, Liverpool L7 8XP (“**the Supplier**”).

Each a “**Party**” and together referred to as “**the Parties**”.

BACKGROUND:

- (A) The Authority and the Supplier entered into a contract entitled “Specialist Pharmacy Services” on 01/09/2022 (“**the Contract**”).
- (B) The Authority and the Supplier have mutually agreed to extend the term of the Contract as detailed below in (2) the Extension Agreement.
- (C) The Authority will pay the Supplier as detailed below in (3) Contract Extension Costs.
- (D) The Authority may terminate this Contract by issuing a Termination Notice to the Supplier at any time on one (1) months’ written notice. Such notice shall not be served within six (6) months’ of the extension Commencement Date.

IT IS AGREED as follows:

1. Definitions and Interpretation

- Capitalised words and phrases in this Extension Agreement shall have the meanings given to them in the Contract.

- The Contract, including any previous Variations, shall remain effective and unaltered except as amended by this Extension Agreement.

2. Contract Extension

- The Supplier and the Authority have mutually agreed to extend the Contract by twelve (12) months.
- The Contract shall be extended from 01 April 2025 to 31 March 2026.
- The contract shall follow NHS England Contract Management Framework.
- The supplier must attend the Contract Performance Board meetings to ensure compliance with the agreed Key performance Indicators as per the principles within NHS England Contract Management Framework

3. Contract Extension Costs

- The Supplier will be paid a maximum* of £2,295,546.33 (Exclusive of VAT) in accordance with the Price detailed in Appendix (1).

*Any additional non- pay allocation requirements must meet NHS England finance requirements and have prior approval from the Contract Performance Board up to a maximum value of an additional £1m
