And, to increase the contract value from 1 <sup>st</sup> July [Redacted Commercial Sensitive].  No other terms will be changed.  <i>NB Under 31.1 of the core terms, Either Party can request a variation to the Contract which is only effective if agreed in writing and signed by a duly authorised representative of both Parties.</i>
