With reference to the contract dated 29th May 2015, (as most recently amended by the letter dated 13th February 2018) both Parties have in principle agreed to the following variations to the Contract:

Section 1: Form of Agreement

1. Commencement and Duration of the Services

DELETE: The Supplier shall start the Services on 1st May 2015 (the "Start Date") and shall complete them by 30th April 2020 (the "End Date") unless this Contract is terminated earlier in accordance with its term and conditions. Inception phase will run from the contract start date to 30th June 2016 (14 months).

INSERT: The Supplier shall start the Services on 1st May 2015 (the "Start Date") and shall complete them by 31st March 2021 (the "End Date") unless this Contract is terminated earlier in accordance with its term and conditions. Inception phase will run from the contract start date to 30th June 2016 (14 months).

INSERT: Payments under this contract shall not, in any circumstances, exceed £14,185,760.00 (of which £2,055,830.00 covers the cost of the Inception Phase and £12,129,930.00 covers the cost of the Implementation Phase) exclusive of any government tax, if applicable (the "Financial Limit").
